



NOTICE OF PUBLIC HEARING
PROPOSED RESOLUTION REVISING THE FEE
FOR DISPOSAL OF APPROVED SOLID WASTE

The Pinellas County Board of County Commissioners proposes to increase the fee for disposal of approved solid waste by Resolution.

A public hearing on the Resolution will be held on **Tuesday, June 21, 2022**, at **6:00 p.m.** in the County Commission Assembly Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Resolution.

THE PROPOSED RESOLUTION INCREASES THE FEE FOR APPROVED SOLID WASTE FROM THE CURRENT RATE OF \$44.70 PER TON TO:

1. \$47.75 per ton effective October 1, 2022.
2. \$51.00 per ton effective October 1, 2023.
3. \$54.50 per ton effective October 1, 2024.

The proposed Resolution can be inspected by the public at the Pinellas County Board Records Department, 315 Court Street, Fifth Floor, Clearwater, Florida 33756. Comments may be sent to this same address or call (727) 464-3458.

Persons are advised that if they decide to appeal any decision made at the meeting/hearing, they will need a record of the proceedings, and, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
