

**FIRST AMENDMENT TO EMPLOYMENT SITES PROGRAM FUNDING  
AGREEMENT**

This First Amendment to the Employment Sites Program Funding Agreement (“First Amendment”) is being entered into as of this 27<sup>th</sup> day of APRIL, 2026 by and between McCormick Stevenson Corporation (“Grantee”) and Pinellas County, a political subdivision of the State of Florida (“County”) (collectively, “Parties”). The Parties hereby amend the Employment Sites Program Funding Agreement between the County and Grantee dated September 23, 2024 as follows:

**WITNESSETH**

WHEREAS, the Parties entered into an Employment Sites Program Funding Agreement dated September 23, 2024 (“Agreement”), for the provision of a one-time economic development grant under the Employment Sites Program (ESP); and

WHEREAS, Section 18 (D) of the Agreement references Exhibit A as the Default and Remedies Repayment Schedule, and

WHEREAS, the Parties desire to amend Exhibit A due to a scrivener’s error.

**NOW, THEREFORE**, the Parties agree to amend the Agreement as follows:

1. The above “WHEREAS” clauses are incorporated into and are made a part of this First Amendment.
2. Exhibit A is hereby amended by replacing the existing attachment in its entirety with the attached revised Exhibit A.
3. Except as herein provided, all other terms and conditions of the Agreement shall remain in full force and effect
4. If there is any conflict between the terms and conditions of the Agreement and the terms and conditions of this First Amendment, this First Amendment shall prevail.
