Hi Don,

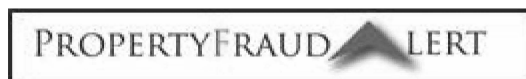

PREVIEW OF COMING ATTRACTIONS,

PAO will go over budget in June of this year (paying 4<sup>th</sup> qtr commission) in the general fund, due to a late budget increase for the elected official salary. We can choose to either plan for a budget amendment, or to adjust budgetary control to combine with the TCO to probably avoid a BA.

2<sup>nd</sup> quarter commissions have been submitted for payment. GF excess fees FY17 revenue is \$111k, against a budget and estimate of \$0.
