Notice is hereby given that the Board of County Commissioners will hold a public hearing during its regularly-scheduled public meeting on **January 26, 2021**, beginning at **2:00 P.M.**, with public hearings being held beginning at **6:00 P.M.** or as soon thereafter as may be accommodated by the completion of the rest of the Board agenda, to consider the petition of Christopher D. Muller, Laura T. Muller, Raymond B. Bennett, and Debra J. Schaefer, to vacate, abandon and/or close the following:

The 80 foot wide right-of-way of Illinois Avenue lying between Lots 6, 7 and 8, Block 135 (920 Illinois Avenue) and Lots 9, 10, 11, and 12, Block 130 (702 9th Street and 945 Illinois Avenue), Map of Sutherland, Plat Book H1, Page 1, lying in Section 2, Township 28, Range 15, Pinellas County, Florida.

Preregistration is encouraged but not required if individuals plan to attend the meeting at the Magnolia Room. Those who have not preregistered may register when they arrive.

The registration form requires full name, address and telephone number if joining by phone, along with the topic or agenda item to be addressed. 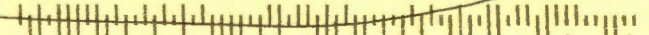

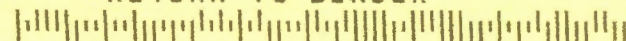
