SECOND AMENDMENT

This Amendment is made and entered into on the date last executed below ("Effective Date"), by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Precision Sidewalk Safety Corp, FL hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on January 31, 2023, referred to as Pinellas County Contract No. 22-0730-PB (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Sidewalk Trip Hazard Prevention and Maintenance for the County; and

WHEREAS, Section twenty-six (26) of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a term extension, at the same prices per the Panhandle Area Educational Consortium (PAEC) RFP # 21-18, and an increase to the contract value, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- The Parties agree to extend the term of the Agreement an additional twelve (12)
 months from September 14, 2025, to September 14, 2026, in conjunction with the
 cooperative procurement.
- Section 6 (Compensation and Method of Payment), the subsection titled "Spending Cap and Payment Structure", is revised to reflect an increase of \$500,000.00 to the current not to exceed amount, for a new total not to exceed amount of \$1,545,000.00.
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect.
