

# **PROPOSED AMENDMENT TO THE PINELLAS COUNTY CODE**

The Pinellas County Board of County Commissioners proposes to adopt the following Ordinance amending the Pinellas County Code. A public hearing on the Ordinance will be held on Tuesday **February 21, 2017 at 6:00 p.m.** in the County Commission Assembly Room, Fifth Floor, Pinellas County Courthouse, 315 Court Street, Clearwater, Florida 33756.

## **A. PROPOSED AMENDMENT TO THE COUNTY CODE**

### **1. LDR-1-1-17**

AN ORDINANCE OF PINELLAS COUNTY, FLORIDA, REGARDING STORMWATER MANAGEMENT STANDARDS; AMENDING CERTAIN SECTIONS OF CHAPTER 154 OF THE PINELLAS COUNTY CODE RELATED TO STORMWATER MANAGEMENT; PROVIDING FOR ADOPTION OF A PINELLAS COUNTY STORMWATER MANUAL TO PROVIDE PROGRESSIVE MECHANISMS TO MEET THESE STANDARDS; PROVIDING FOR FINDINGS; PROVIDING FOR PURPOSE AND INTENT; PROVIDING FOR INCLUSION IN THE CODE; PROVIDING FOR SEVERABILITY; AND PROVIDING AND EFFECTIVE DATE.

Any written arguments, evidence, explanations, studies, reports, petitions or other documentation that an applicant, proponent or opponent wishes to be provided to the Board of County Commissioners for their consideration in support of, or in opposition to, any of the applications proposed above should be submitted to the attention of the Pinellas County Zoning Manager, 440 Court Street, Fourth Floor, Clearwater, Florida 33756. Materials must be submitted at least one week (7 days) in advance of the advertised hearing. Hard copy written comments must be submitted on 8½ × 11-inch paper.

The proposed amendment to the Pinellas County Code can be inspected by the public at the Pinellas County Planning Department, located at 310 Court Street, First Floor, Clearwater, Florida 33756. Send comments to this address or call the Department at (727) 464-8200.

Persons are advised that, if they decide to appeal any decision made at this meeting/hearing, they will need a record of the proceedings, and, for such purpose, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
