The current playground at the Tierra Verde Complex has come to the end of its cycle and is in bad need of repairs.

(Required)</b>	The TVCA Board is requesting that the BOCC vote to approve \$20,000.00 in MSTU Funds to go towards the cost of the needed repairs. The total estimated cost of the repairs is \$25,075.76. The TVCA Board has voted to approve the difference in the cost of \$5,075.76 and since the repairs need to be completed as soon as possible they have voted to pay for the repairs upfront and request the BOCC to reimburse TVCA if the Funds are approved.
<b>Program Outcomes: Describe the time-line by which the project will be implemented including short-term and long-term results. (Required)</b>	The playground repairs should be completed by the end of August 2021. Once the repairs are completed, the life cycle of the playground should be around 4 to 5 years.

Repairing the playground equipment will allow the children to safely utilize the equipment and give their parents a peace of mind.
