

Community Development Block Grant – Disaster Recovery (CDBG-DR) Funding

for Hurricanes Idalia, Helene, and Milton

The U.S. Department of Housing and Urban Development (HUD) directly awarded Pinellas County \$813,783,000 in Community Development Block Grant – Disaster Recovery (CDBG-DR) funds to support long-term recovery efforts following Hurricanes Idalia, Helene, and Milton. CDBG-DR funding supports disaster relief, long-term recovery, restoration of infrastructure and housing, economic revitalization and mitigation in the most impacted and distressed areas, according to HUD. These funds are designated to primarily benefit lowand moderate-income households and communities.

To access these funds, Pinellas County must develop an Action Plan for HUD review and approval. The Action Plan is the County's blueprint for identifying and funding CDBG-DR recovery and mitigation programs based on existing unmet disaster recovery and mitigation needs. The County cannot execute its grant agreement with HUD and begin to expend CDBG-DR funds without a HUD-approved Action Plan.

As required by Federal Register Notice Vol. 90, No. 5, published Wednesday, January 8, 2025, Pinellas County will host public meetings to discuss the proposed Action Plan for CDBG-DR funds, on the dates, times and locations shown below:
