## NOTICE OF PUBLIC HEARING PROPOSED ORDINANCE AMENDING THE PINELLAS COUNTY CODE

The Pinellas County Board of County Commissioners proposes to amend the Pinellas County Code by Ordinance.

A public hearing on the Ordinance will be held on Tuesday October 15, 2024, at 9:30 A.M. in the Pinellas County Communications – Palm Room, 333 Chestnut Street, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Ordinance.

## 1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:

AN ORDINANCE OF THE COUNTY OF PINELLAS, PROVIDING THAT THE PINELLAS COUNTY CODE BE AMENDED BY REVISING SECTION 126-302 OF SAID CODE; PROVIDING FOR ADJUSTMENTS TO THE PROCEDURE FOR CONVERTING SEPTIC SYSTEMS TO SANITARY SEWER CONNECTIONS; PROVIDING AUTHORITY FOR THE COUNTY ADMINISTRATOR TO GRANT EXCEPTIONS; PROVIDING FOR ADMINISTRATION OF THE ORDINANCE; PROVIDING FOR SEVERABILITY AND AREAS EMBRACED; PROVIDING FOR FILING, CODIFICATION, AND PROVIDING FOR AN EFFECTIVE DATE.
