The building is currently being utilized by a Cub Scout Pack (ages 5-10) and a Scout Troop (ages 11-18). Our Scout Hut is 50 years old. Most of the windows and metal doors are original to the building. The door frames are rusted and the building cannot be secured properly. The windows are not efficient, several have cracks. Neither the doors nor windows are code compliant. The Cub Scouts and Scout Troop help prepare young people to make ethical and moral choices by teaching them the values of the Scout Law and Oath. It is important to have a safe and secure building to foster the Sccout values. To provide for our community needs we are requesting a \$20,000 grant for the following:

- 1.) 6 Windows To provide safety and security for the bulding, new hurricane rated windows need to be installed. The original windows were installed in 1975. \$9848.00
- 2.) Doors The doors are all original to the building as well (1975). These are currently steel doors that need to be upgraded for safety and security. There is one rear door and a front double door. \$9100.00
- 3.) Environmentally friendly mower. \$649.00
- 4.) Environmentally friendly edger/trimmer. \$449.00 Total Cost \$20,046.00

Once funding is procured, our goal is to start our improvement projects in a timely manner making sure that they do not interfere with any activities or events in the downtown historic district of Palm Harbor. Project will be implemented and completed, ideally, during summer months when no youth are utilizing the facilities due to safety concerns during construction.

- 6.) Lanscaping at the Ozona Village Hall for OVIS, Ozona Village Improvement Society.
- 7.) Scattergarden at teh DunedinMunicipal Cemetery.
- 8.) Kiosk at Pop Stansell Park by the dock (former dock).
- 9.) Lanscaping at Pop Stansell lift station
