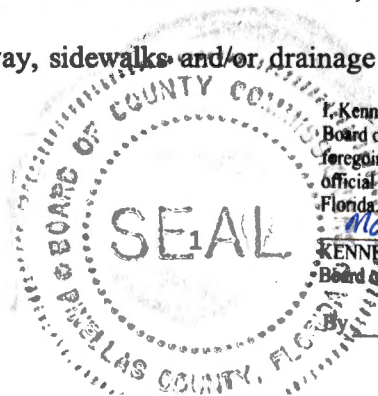

**WHEREAS,** County holds title in fee simple to a portion of Lots 23, 24, 25 and 26 lying in the Northwest ¼ of Section 9, Township 30 South, Range 15 East, Pinellas Groves, recorded in Plat Book 1, Page 55, of Public Records of Pinellas County Florida per Deed Book 823, Page 227, Public Records of Pinellas County Florida ; and

**WHEREAS,** County holds title in fee simple to a portion of Lot 8 lying in the Southwest ¼ of Section 9, Township 30 South, Range 15 East, Pinellas Groves, recorded in Plat Book 1 Page 55, of Public Records of Pinellas County Florida per Deed Book 920, Page 351, Public Records of Pinellas County Florida; and

**WHEREAS,** the parcel as described in “EXHIBIT A”, attached hereto has been improved by the County, including roadway, sidewalks and/or drainage improvements and is needed for public right-of-way; and



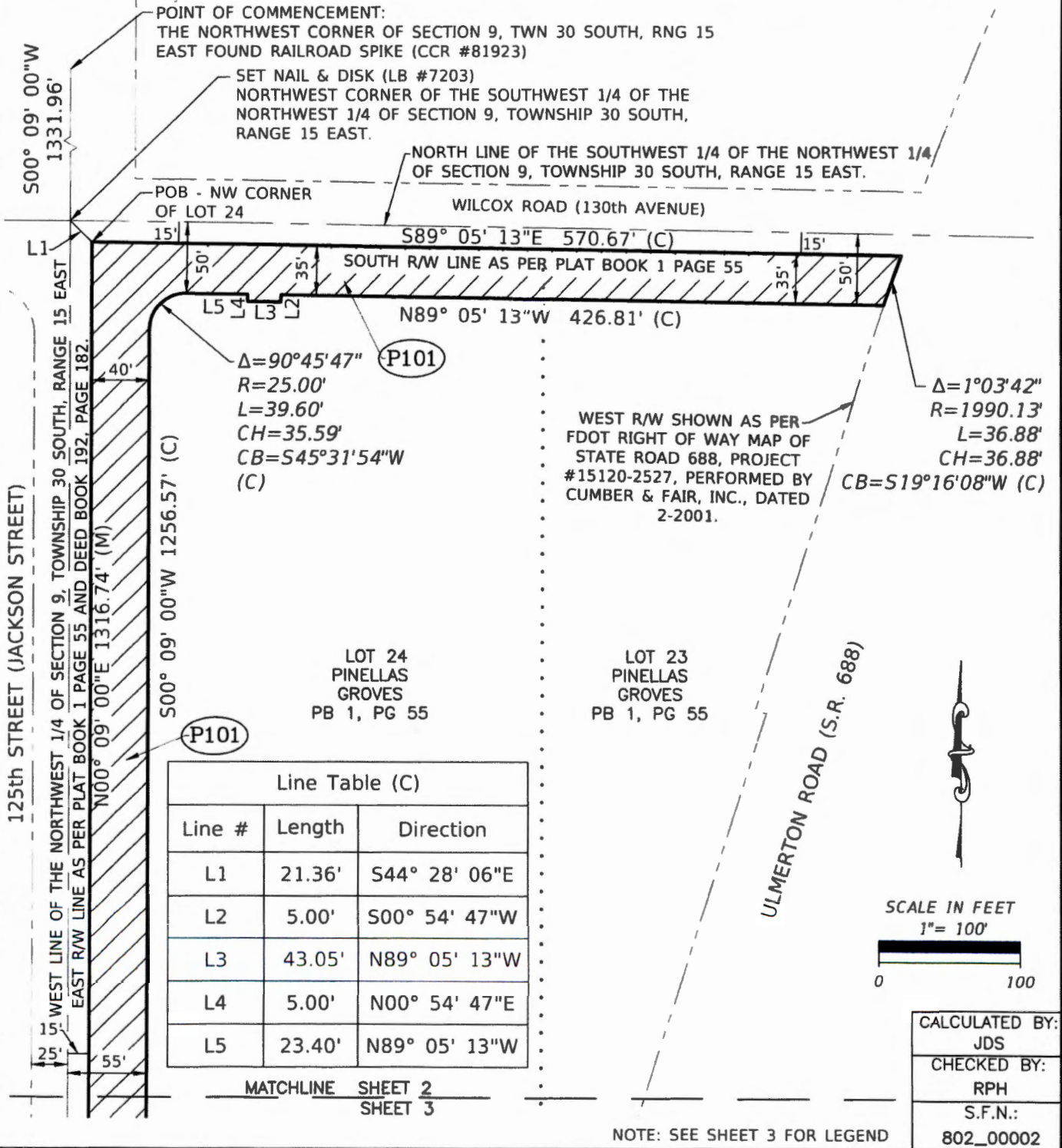

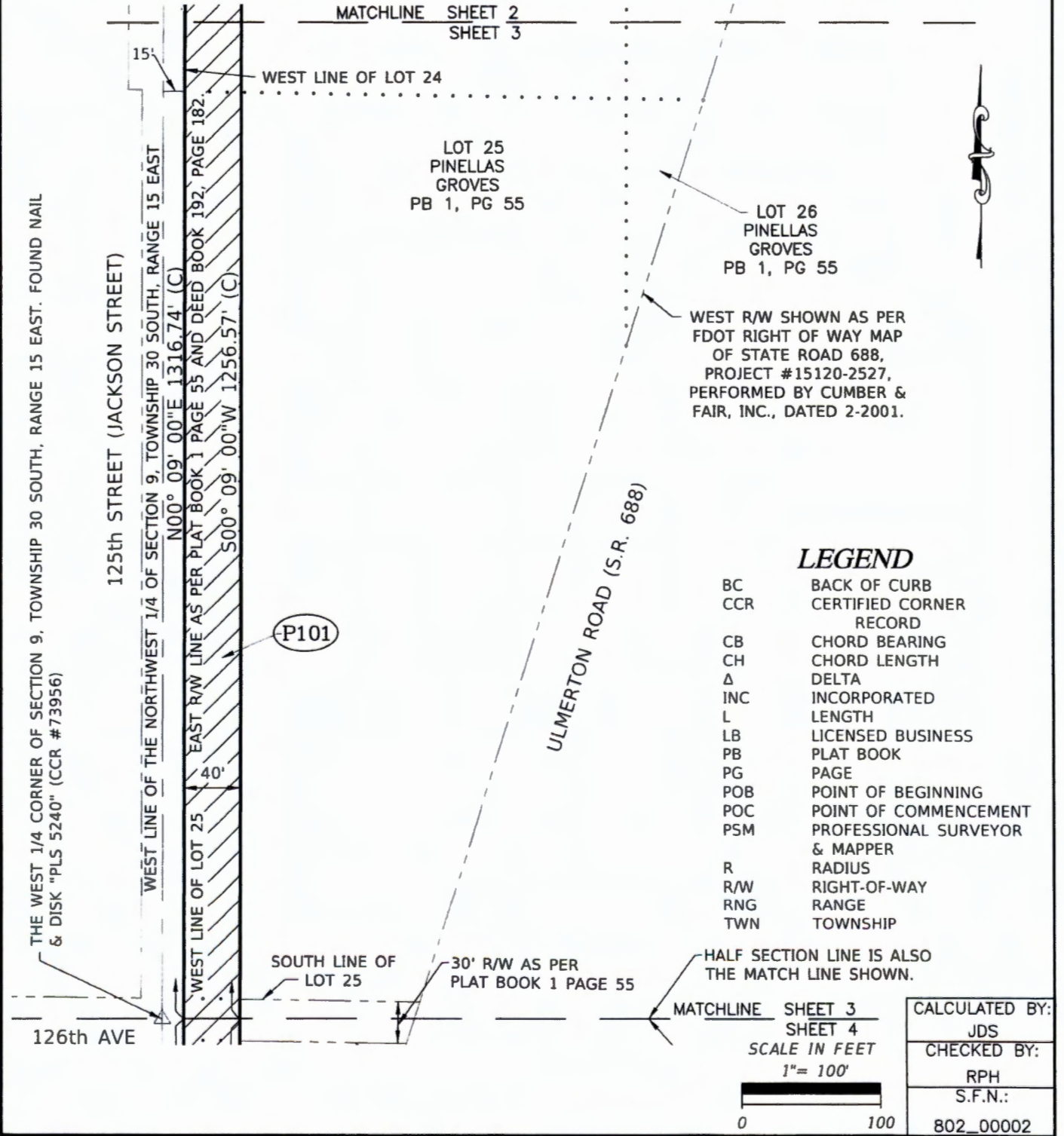

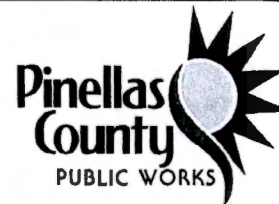

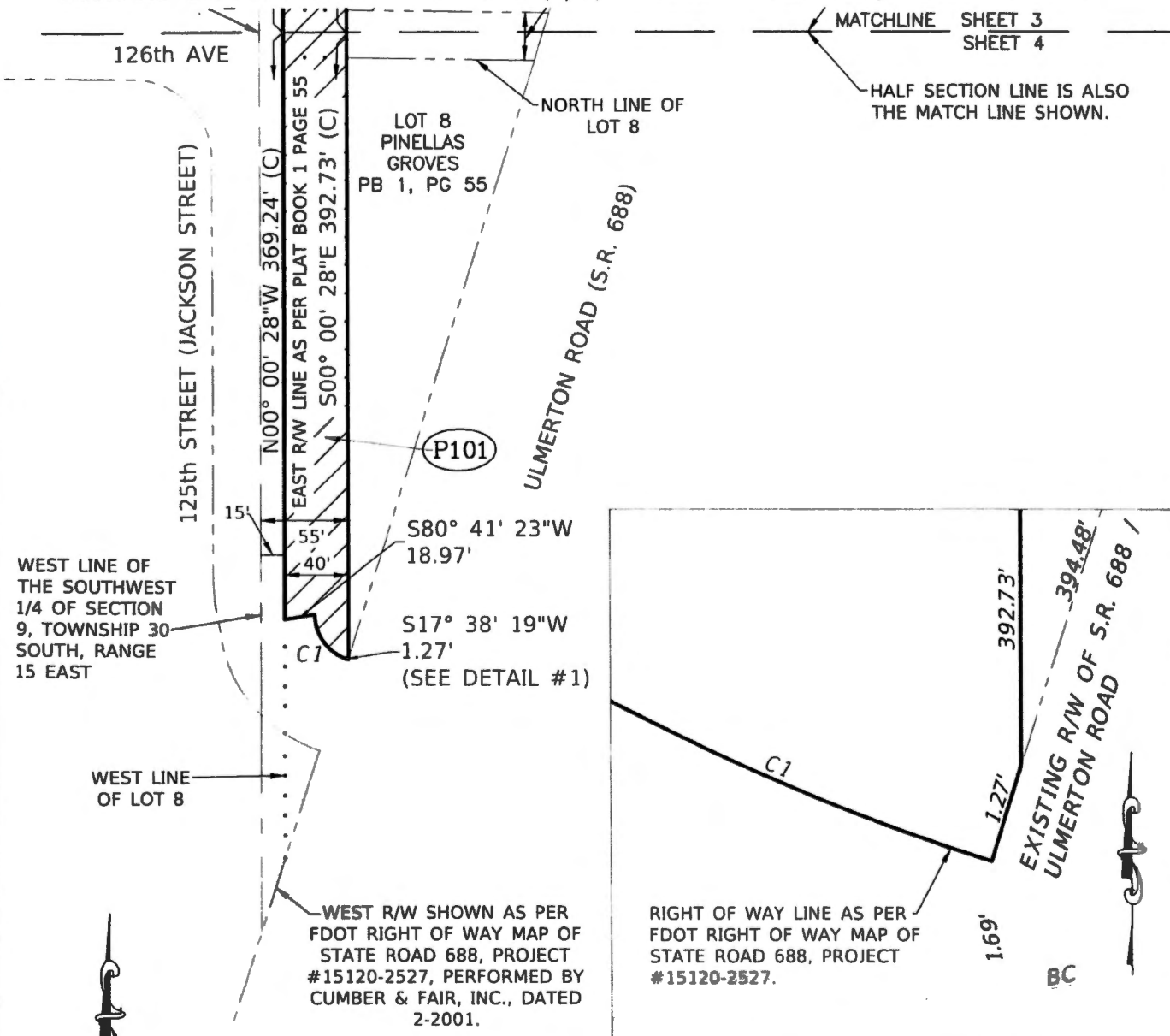

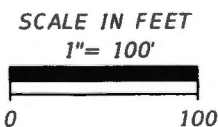
