Subject: Call for Submittals: Applications for the Beach Management Funding Assistance Program's FY 2017/2018 Local Government Funding Request

Dear Coastal Stakeholders,

The Beach Management Funding Assistance Program is developing the annual prioritized list of beach and inlet management projects for inclusion in the Department's FY 2017-2018 Local Government Funding Request (LGFR). **The deadline for application submittals will be August 1, 2016.**

Consistent with last year, the following modifications have been made to the application process for FY 2017-18:

- An Application Supplement can be used for projects on last year's list **that remain unfunded**. Last year's funding request will be duplicated, allowing for minor modifications in the funding table.
- A complete application must be submitted for new requests or for unfunded projects with significant changes/additions.
- Mapping elements, Federal Project Cooperative Agreements/Participation Agreements, interlocal agreements, designated long term funding source documentation, and FEMA documentation **will not need to be re-submitted** if staff has a copy of these documents on file and if they are unchanged from the last submittal.
- Documentation/licensure for Public Lodging Establishments must be provided with website links to the specific licenses from the Department of Business and Professional Regulation (DBPR) webpage:

- There will be no formal Request for Additional Information period (RAI). Department staff can assist you by reviewing your application prior to the submittal deadline to ensure all required information has been provided.
- **The current local government resolution signed by the local sponsor's governing board must be submitted by September 30, 2016**, for the project to be included in the final LGFR.

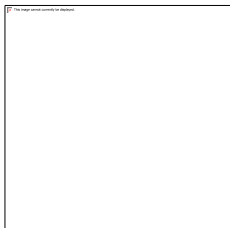
