


Introduction

The City of Largo is known as the "City of Progress" and is located in the center of Pinellas County, Florida. The municipality is the County's third most populous city and growing. Originally founded when the Orange Belt Railroad expanded into West Florida in 1886, the City's traditional urban core formed around the railroad station, original City Hall and library. Over the next 100 years Largo became the "City of Progress" and transformed into an urban activity center with new roadways, office towers, homes and shopping centers.

To provide direct assistance in its revitalization and redevelopment efforts, the City of Largo's City Commission created the Community Redevelopment Agency (CRA) in 1997. The Largo City Commission, in their role as the CRA Board, identified Downtown Largo as an area in need of revitalization. The West Bay Drive Community Redevelopment District (WBD-CRD) Plan was developed and adopted by Largo as a policy document to protect and enhance the district's tax base through redevelopment endeavors by the private sector and through public improvements. The intent of the Plan is to eliminate blight, create a sustainable downtown, encourage economic growth and improve the attractiveness and quality of life for the City of Largo as a whole.

The Clearwater-Largo Road Community Redevelopment District (CLR-CRD) is also administered by the CRA Board. The CLR-CRD has a redevelopment plan that was first adopted in 1996, authorized in 2002 by the Pinellas County Board of County Commissioners and subsequently amended in 2006. The CLR-CRD Plan represents a community-based effort to shape the future of the district. The Plan guides policy changes and the investment of limited resources for maximum aesthetic, economic and social impact within the area.

The WBD-CRD is primarily funded through tax increment revenues, and most of those funds are put directly into infrastructure improvements. Properties located in the WBD-CRD do not pay any additional property taxes. Rather, a portion of the annual City and County taxes collected in the redevelopment area are transferred to the CRA for redevelopment activities. Largo's Tax Increment Financing (TIF) District for the WBD-CRD was established in 2000 and is used to leverage public funds to promote private sector activity, redevelopment and infrastructure projects for the area in accordance with the redevelopment plan.

While Largo continues to make investments from the City's General Fund and other sources in the CLR-CRD, no TIF funding mechanism is currently in place for the District. Largo is currently working on a finding of necessity assessment that is proposing an expansion of the District and a request for a TIF for the new area.

The CRA publishes an Annual Report on the progress of the year's redevelopment and infrastructure projects along with an overview of the financial statement for the TIF District. This annual report is being submitted to meet the FY 2015 statutory reporting obligations as required by Chapter 163.356(3)(c) of the Florida Statutes.

Highlights

West Bay Drive Community Redevelopment District Medical Arts District Master Plan

The West Bay Drive-Community Redevelopment District (WBD-CRD) Plan features a Medical Arts District in the south west corner of the redevelopment area that was established to reflect the importance of the medical sector as a community asset. The District is characterized by several major medical institutions including Largo Medical Center, the Diagnostic Clinic and the Eye Institute of West Florida. In 2015, the Community Redevelopment Agency approved a contract to produce a conceptual master plan for the district. The proposed conceptual master plan will evaluate the District as a medical campus and identify future infrastructure needs to support the continued development of medical and supporting land uses. A key component of the project will be the engagement of the property owners in the district in order to incorporate and accommodate their future plans for their properties along with a solid master plan for long term growth of the district.

West Bay Drive Trail Head

The City's Downtown Largo Multimodal Plan identifies projects needed to improve the bicycle and pedestrian network to make transit and transportation alternatives more convenient and more safe. The purpose of the West Bay Drive Trail Head Project is to improve the areas adjacent to the Pinellas Trail within the WBD-CRD and to provide trail access, connections to downtown businesses, residential neighborhoods and to enhance trail aesthetics. A Scoping Meeting was held by staff in March 2015 to refine and define the project scope and work that will need to be completed by the consultant. The scope of work that the City will seek includes outreach activities to businesses, residents and trail users, public information materials, and a review of potential design for the public amenities including public art, seating, parking, shelter, landscaping and a wayfinding signage program.

Grants

The WBD-CRD Downtown Events Promotion and Assistance Program provided grants to three events during the 2015 Fiscal Year:

The Community Redevelopment Agency approved a request for the first Housing Infill Program Grant in the WBD-CRD for the 158 Ridge Road Apartment Homes project. The new apartment complex will feature 29 urban loft-style apartment homes with an investment in excess of \$3.6 Million dollars. The project's developer was awarded a grant in the amount of \$8,000 per unit for each infill apartment. Groundbreaking for this project is expected in early Spring 2016 and completion in 2017.

New Construction

In Fiscal Year 2015, a new 4,352 Square Foot Chase Bank was constructed and completed at 821 West Bay Drive.



The existing Largo High School, sits on the periphery of the West Bay Drive Community Redevelopment District, but is a major anchor in Downtown. The existing

Largo High School's 1957 brick buildings were in dire need of replacement and the new configuration emphasizes security and safety. The 242,000 Square Foot design features over 1,600 student stations and increases the gymnasium capacity by over 1,000 seats. The new site planning and design also resolves vehicular circulation issues that effectively manage traffic during rush hour events. Construction is expected to be completed in the Fall of 2016.



The Central Pinelias Chamber of Commerce opened in the Fall of 2015 in their new location at 801 West Bay Drive.

Demographics

Population Statistics

The Redevelopment Districts have a combined population of 5,592 persons which makes up 7% of the total Largo population. The highest population is within the Clearwater Largo Road District with 3,995 persons. Both districts experienced an increase over previous years with the greatest increase year over year being in the Clearwater Largo Road District.

There are 1,479 households within both districts with an average of 2.18 persons in their households. The national trend of declining owner occupied housing is evident within the districts. There was a 6% drop over previous years.

Median age for the Redevelopment Districts shows that the West Bay Drive District is at 44.3 year and in the Clearwater Largo Road District there is a much younger median age of 42.9 years. Both Districts have median ages younger than the overall Largo median age of 49.6 years.

A review of the Median Household Income for both districts shows that the West Bay Drive District has significantly increased over last year and is now \$35,263, an increase of 6.5%. However, Clearwater Largo Road has experience a decline over the previous year and has a Median Household Income of \$30,960 a reduction of 7%.

Business Data

Within the two Redevelopment Districts, the West Bay Drive District has the largest business presence within the downtown. Overall there 485 businesses in the downtown with a total employment of 5,227 persons. West Bay Drive has 76% of the businesses and 78% of the employment. Top employers within the downtown are Pinellas County Schools, Largo Medical Center and the Diagnostic Clinic.

Largo Central Park Complex

- Largo Public Library is the largest municipal library in Pinellas County and is located within the Central Park complex. During FY2014-2015, the Library welcomed 520,571 visitors and distributed 5,328 new library cards. The youth program served almost 28,806 children through their various programs and tours. The circulation count for the Largo Library in FY2014-2015 was 907,997.
- During FY2014-2015 the Largo Cultural Center entertained and served more than 25,450 persons through facility rentals. The Cultural Center held 132 performances in the with an average ticket price of \$31 for the FY2015 events. A total of 76 students participated in the youth programming.



Future CRA and City Initiatives

The City and CRA have several initiatives based on the 2016 Adopted Budget and Capital Improvement Budget for incentives, infrastructure, multi-modal improvements and studies. The initiatives are subject to budget constraints and may change at any time.

Urban Trail and Downtown Multi-modal Gateway Improvements

The West Bay Drive Urban Trail Head Project and multi-modal gateway improvements will connect the Pinellas Trail to the Downtown Largo neighborhoods and commercial center. This project will also address two (2) segments of West Bay Drive and will make critical repairs and rehabilitation of existing roadway pavement, sidewalks, and curb ramps. Improvements will include a gateway monument at the Pinellas Trail crossing with a trail head and wayfinding signs, landscaping, roadway retrofit and bike facilities. Additional improvements will include a gateway monument and plaza improvements to the triangular parcel at the Southwest corner of West Bay Drive and Missouri Avenue. The project will feature a roadway retrofit with bike facilities, mid-block intersection improvements and pedestrian safety modifications. Staff has applied for the Fiscal Year 2016 Southwest Florida Water Management District Cooperative Funding Initiative grant to provide additional funding for the Urban Trails Segment. The total project cost for Fiscal Year 2016 is \$1,008,000. This figure includes \$400,000 from a grant from the Florida Department of Transportation, \$450,000 from the CRA-WBD Fund, \$38,000 in Stormwater Funding, \$115,000 in Tree Funding, and \$5,000 from the General Fund.



Medical Arts District Master Plan

The purpose of this project was to engage stakeholders within the West Bay Drive Community Redevelopment District to prepare a master plan that will include recommendations for parking management; multimodal and streetscaping improvements; and redevelopment strategies to create a more coherent medical district with appropriate supporting land uses. The role of stakeholder engagement in the project is critical so that the master plan reflects future needs of property owners, employees, and the community. The cost for professional services for this Master Plan totals \$30,000 from the CRA-WBD Fund, of which the study began and was completed in Fiscal Year 2015. The Community Redevelopment Agency will move forward to determine the feasibility of recommendations resulting from the report. At this time there is no additional funding budgeted for the Master Plan.

Future CRA and City Initiatives (continued)

1st Avenue NE Roadway and Innfrastructure and Infrastructure Improvements - 1st Avenue Southwest

This project will take place within the West Bay Drive Community Redevelopment District, and will address multiple infrastructure improvements. The improvements will reconstruct 1st Avenue NE, from Missouri Avenue to 4th Street NE, in coordination with the redevelopment of Largo High School. The current road is constructed of red clay brick and is in a state of disrepair with numerous depressions and patches in the road surface and poor rainwater drainage. The Pinellas County School Board (PCSB) will be performing sanitary sewer and storwater improvements within the 1st Avenue NE right-of-way as part of the Largo High School construction. The City of Largo is coordinating improvements with PCSB to repair the road, construct new sidewalk and relocate underground utilities. The scope of work includes restoration of the failed brick surface, concrete sidewalks, traffic calming, stormwater and wastewater infrastructure. The total project cost is \$420,000. This figure includes \$213,000 in CRA-WBD funding, \$93,000 in CGT funding, \$60,000 in TIF-7A funding, \$39,000 in Stormwater funding, and \$15,000 in Tree Funding.

Braginton Street Sewer Expansion

This project will entail a sewer system expansion on Braginton Street from Clearwater-Largo Road, to the end of the Braginton Street to the west servicing properties in the Clearwater-Largo Road Community Redevelopment District that are not currently serviced by the City's Sanitary Sewer System. The project will begin in Spring 2016 and includes a new sanitary sewer gravity main, sanitary sewer service laterals to the properties along the road, and roadway improvements. The improvements will include the elimination of 6 septic tanks and one private lift station. Tree removal, utility modification and re-sodding of the rights-of-way is also included in this project. The total capital cost for this sewer expansion will be \$410,000 from the Wastewater Fund.
