

MEMORANDUM OF UNDERSTANDING

This Memorandum of Understanding (hereinafter "MOU") is made and entered into this _____ day of _____, 2016, by and between PINELLAS COUNTY, a political subdivision of the State of Florida, (hereinafter "County"), and the SCHOOL BOARD OF PINELLAS COUNTY, FLORIDA (hereinafter "School Board") by and through the Superintendent of Schools.

WITNESSETH:

WHEREAS, the County is a "local emergency management agency" pursuant to Chapter 252, Florida Statutes, and therefore has the responsibility for Emergency Management for the County; and

WHEREAS, the parties desire to cooperate in the interest of public safety by providing shelter facilities before, during, and following a disaster; and

WHEREAS, the School Board is undertaking certain enhancements in the areas of life safety at East Lake Middle School, Classroom Buildings 1, 2 and 3 including but not limited to, installing an emergency well for potable water supply system, emergency power to the ventilation fans units, control devices select power and lighting devices in rooms and corridors, fire alarms and smoke dampers, to provide emergency power of the for a period of 16 hours. In addition to extending the emergency water supply to the existing East Lake High School Building 7 group restrooms 105, 106 and to the existing kitchen room 122.

WHEREAS, the County would use Building 1, 2 and 3 at East Lake Middle School for hurricane risk shelter space for the public; and

WHEREAS, the County herein agrees to provide funding not to exceed a total of \$370,808.64 for the work specified in the attached Scope of Work and Construction Capabilities

Document; and

NOW, THEREFORE, in consideration of the premises and of the mutual covenants, terms and conditions herein set forth, the parties agree as follows:

Section 1. Purpose.

In order to increase its Emergency Management Shelter Capability, the County agrees to provide funds to the School Board to have the enhancements and retrofits completed at East Lake Middle School as outlined in the Scope of Work and Construction Capabilities Document attached hereto and incorporated herein by reference.

Section 2. Obligations of the School Board.

The School Board shall contract for all the necessary design and construction work related to the attached Scope of Work and Construction Capabilities Document; and shall utilize a competitive, public process to select Vendors to perform such work. The School Board shall be solely responsible and liable for the operation and maintenance of the enhancements and retrofit items at East Lake Middle School constructed in accordance with the attached Scope of Work and Construction Capabilities Document. Additionally, the School Board shall be solely responsible for resolving any disputes arising or resulting from any contract disputes connected to performance of the attached Scope of Work and Construction Capabilities Document, and shall be responsible for insuring that the Scope of Work and Construction Capabilities are completed. The School Board agrees to refund any monies provided by the County in accordance with this MOU for work not completed in accordance with the Scope of Work and Construction Capabilities Document. All of such work has, in fact, been completed and the dates of the projects were as follows: October 2014 through April 2016.

Section 3. Obligations of the County.

The County herein agrees to provide funds up to amount of \$370,808.64 for the enhancements and retrofit work identified in the Scope of Work and Construction Capabilities Document. The County shall not be responsible for the ongoing operation and maintenance of the enhancements and retrofit items at East Lake Middle School. The funding source(s) for this project shall come from the Pinellas County Capital Improvement Fund, Emergency Management Department, Community Building Emergency Shelter Projects account, and Aid to Government Agencies.

Section 4. Payment.

The County shall make payment(s) to the School Board in an amount up to and including \$370,808.64 for the work as scheduled in the attached Scope of Work and Construction Capabilities Document and in accordance with any and all deliverables as set forth in the Scope of Work and Construction Capabilities Document. All payments shall be made in accordance with the Florida Local Government Prompt Payment Act (Section 218.70, et. seq. *Fla. Stat.* (2014)) and shall be made based upon the substantial completion points occurring during the course of the Scope of Work and Construction Capabilities Document with final payment occurring upon satisfactory demonstration to the County of project completion, inspection and testing of said enhancements stated in the Scope of Work and determination that the items in the Capabilities Document have been provided for.

Section 5. Indemnification and Disclaimer.

Notwithstanding any other provision in this MOU, the School Board assumes all risks relating to performance of the Scope of Work and Construction Capabilities Document and agrees to be solely liable for any claims, loss, damage, and other expenses, including attorney's fees and costs, arising from performance of the Scope of Work and Construction Capabilities Document, to the extent permitted by Sect. 768.28, *Fla. Stat.* (2014). The County expressly disclaims any and all

responsibility or liability to the School Board or third persons for the actions of the School Board or third persons resulting in death, bodily injury, property damage, or any other losses resulting in any way from the School Board or third person's performance of the Scope of Work and Construction Capabilities Document. The acceptance by the School Board of funding from the County under this MOU does not in any way constitute an agency relationship between the School Board and the County. Additionally, nothing in this MOU shall be interpreted as a waiver of the County's or School Board's sovereign immunity or an extension of their respective liability beyond the limits established in Section 768.28, *Fla. Stat.* (2014).

Section 6. Effective Date and Termination.

This MOU shall become effective upon the signing by both parties. This MOU shall continue in force and effect until the completion of the performance of the Scope of Work and Construction Capabilities Document and completion of the obligations of the parties hereunder, or until terminated by mutual consent by the parties as evidenced in writing. Additionally, this MOU may be terminated for lack of appropriation of funds described in paragraph 7. below. Notice shall be given to the other party and delivered by certified mail, return receipt requested, to the following individuals as designated by the County and the School Board:

Section 7. Fiscal Non-funding

It is understood that neither this MOU nor any representation by any County employee or officer creates any obligation to appropriate or make monies available for the purpose of the MOU beyond the fiscal year in which this MOU is executed. No liability shall be incurred by the County, or any

department, beyond the monies budgeted and available for this purpose. If funds are not appropriated by the County for any or all of this MOU for a new fiscal period, the County shall not be obligated to pay any sums provided pursuant to this MOU beyond the portion for which funds are appropriated. The County agrees to promptly notify the School Board in writing of such failure of appropriation, and upon such notice, this MOU shall terminate on the last day of the current fiscal period without penalty to the County.

Section 8. Entire Agreement.

This MOU constitutes the entire agreement between the parties, may be amended, only in writing and signed by all parties to this MOU.

East Lake Middle School

NAME OF PROJECT:

East Lake Middle School

GENERAL SCOPE OF WORK:

Provide design and contract administration services, and construction for Pinellas County Emergency Management enhancements to the East Lake Middle School facility. The enhancements shall include the following: Potable water well including a sterilization system to serve East Lake Middle School buildings 1, 2 and 3 as well as East Lake High School Building 7 Rooms 105, 106 and 122. Emergency power supporting emergency lights and select emergency power outlets, fire alarms and smoke dampers, ventilation fan units for air circulation at Buildings 1, 2 and 3. Emergency power for the potable well pump system. The enhancements to the facility will allow a shelter occupancy for 700 people to be housed in Building 1, 2 and 3. Instruction manuals for the enhancements will be completed and made available on site, with copies provided to Emergency Management and also located at school district administration offices. These manuals should be in plain language, and detailed enough that a layperson can activate and operate the enhancements without significant technical instruction.
