OMB has no objection to the department submitting a grant application to the US Department of Justice, Bureau of Justice Assistance to obtain funding to expand and enhance the capacity of the Sixth Judicial Circuit's Adult Drug Court Program.

Requested funding is \$500,000 from the FY20 Adult Drug Court Discretionary Grant program. A 25% match is required, \$166,667. No County funds are expected to be used for the match. The match will be in-kind, of eligible court expenses. Total project cost is estimated to be \$666,667. The period of performance is 36 months, 3 years.

Proposed Abstract (Project Scope of Work): Pinellas County is requesting BJA grant funds in the amount of \$500,000 (\$166,666 per year for up to three years) to implement the AURORA Project, which expands and enhances the capacity of the Sixth Judicial Circuit's Adult Drug Court program. This expansion will enable the Sixth Judicial Circuit, in partnership with its treatment provider, Center for Rational Living, to improve its ability to effectively provide meaningful therapeutic services to the target high risk population of individuals with history of sexual abuse and/or victims of human trafficking.

Benefit Summary (How will this benefit the County, Dept, etc?): During the three-year grant period, 2020 to 2023, the AURORA project will serve 100 offenders. By improving services provided to the target population, the Sixth Judicial Circuit will continue to build on reducing crime and substance abuse among high-risk/high-need, nonviolent offenders who are diagnosed with substance abuse disorders. The goal of the proposed program is to address the needs of this high-risk/high-need population, which is currently underserved, and provide an effective client-centered therapeutic program addressing both substance abuse and trauma related issues.
