Paul & Amy Palmer Claim # 14-11037 Incident Date: 4/9/2014

Claimants, Paul & Amy Palmer, unknowingly purchased a home that was partially built over a Pinellas County sewer main. The sewer main, which was located outside the easement, was built in the 1950's and acquired from Kenneth City in the 1960's. The Palmers believed that the sewer main was leaking and causing noxious gases to enter the home, making the home unhabitable. The home was sold in foreclosure and the Palmers lost their investment in the home. The plaintiff's sought to recover the full value of the home, but through much negotiation in litigation they agreed to settle for \$50,000.00.

Alice Wright Claim # 17-20747 Incident Date: 5/23/2017

Claimant, Ms. Wright, a retired Pastor, alleged that she tripped and fell on a raised & cracked portion of a Pinellas County sidewalk. As a result of this fall, Ms. Wright fractured her left wrist, which required surgery. Pinellas County replaced the raised section of sidewalk and ground down several other areas. The plaintiff's attorney demanded \$200,000.00 pre-suit, then served a proposal for settlement for \$65,000.00 and through much negotiation, they agreed to settle for \$50,000.00.

Alexis CampbellClaim # 18-20475Incident Date: 10/24/2018

Claimant, Ms. Campbell, was driving through a Publix parking lot when a County vehicle pulled out and sideswiped her vehicle. The PCU driver was found at fault, but not cited. Ms. Campbell claimed various soft tissue injuries to neck, shoulder and back. The plaintiff's attorney demanded \$175,000.00 pre-suit, and through much negotiation in litigation, they agreed to settle for \$50,000.00.

Margaret Burris

Claim # 18-20610

Incident Date: 9/7/2018

Claimant, Ms. Burris, alleged that she tripped and fell on a raised portion of a Pinellas County sidewalk. As a result of this fall, Ms. Burris fractured and displaced her left shoulder, which required surgery. Pinellas County replaced the raised section of sidewalk, which had been previously ground down. The plaintiff's attorney served a proposal for settlement for \$200,000.00, and through much negotiation in litigation, they agreed to settle for \$47,500.00.

Richard Ludlow

Claim # 97-32247

Incident Date: 3/31/1997

Employee worked for the Clerk of Courts and had a claim for an exposure to chemicals while he was working in the print shop. This exposure permanently aggravated his pre-existing medical condition. He continued to work for the Clerk's Office until his retirement. Prior to retirement he requested that we evaluate his claim for a possible settlement. His claim was evaluated and settled for \$50,000 thereby eliminating future medical and indemnity exposure.
