Proposed Abstract (Project Scope of Work):	<p>The Criminal Lab Financial Assistance Agreement allows the County to receive financial support from FDLE to fund up to 75% of PCFL's operating costs. The agreement is funded by criminal fines collected statewide, pursuant to Sections 938.07 and 938.55 Florida Statutes.</p> <p>The funds are disbursed to the County on behalf of the laboratories according to a pre-determined distribution based on a percentage of the population served. There is also no grant application only notification of the next fiscal year's award. The contract from FDLE serves as both the application and award acceptance.</p> <p>Pinellas County will receive 12.67% of the total collected funds so budget amount is an estimate based on total disbursements in FY17.</p>
Benefit Summary (How will this benefit the County, Dept, etc?):	This agreement supplements the County's funding of the PCFL's operating costs, reducing PCFL's reliance on local general revenue and funding support.
