

RESOLUTION NO. 23-100

RESOLUTION DEDICATING COUNTY OWNED PROPERTY LYING IN A PORTION OF LOT 6, PINELLAS GROVES, IN THE NORTHWEST ¼ OF SECTION 9, TOWNSHIP 30 SOUTH, RANGE 15 EAST, ACCORDING TO PLAT THEREOF, AS RECORDED IN PLAT BOOK 1 PAGE 55 OF PUBLIC RECORDS OF PINELLAS COUNTY, AND A PORTION OF THE NORTHWEST ¼ OF SECTION 9, TOWNSHIP 30 SOUTH, RANGE 15 EAST AS PUBLIC RIGHT-OF-WAY FOR 134TH AVENUE NORTH; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, Pinellas County (the “County”) holds fee simple title to certain real property as recorded in Official Records Book 22462 and Page 1634, of Public Records of Pinellas County, Florida, lying in Lot 6, Pinellas Groves, in the Northwest ¼ of Section 9, Township 30 South, Range 15 East, according to the plat thereof recorded in Plat Book 55 Pages 1, of Public Records of Pinellas County Florida (the “Property”);and

WHEREAS, the Property, more fully described in EXHIBIT ”A”, attached hereto and fully incorporated herein, has either been improved by the County, including roadway, sidewalks and/or drainage improvements, or is needed for public right-of-way; and

WHEREAS, it is necessary for the County to dedicate the Property as described in “EXHIBIT A” as public right-of-way; and

NOW THEREFORE, BE IT RESOLVED by this Board of County Commissioners of Pinellas County, Florida, duly assembled on the 31st day of October, 2023, hereby dedicates as public right-of-way this parcel located on a portion of Lot 6, of “Pinellas Groves”, as depicted in Exhibit A, attached hereto, and authorizes the Clerk of the Circuit Court to certify and record this dedication of public right-of-way.

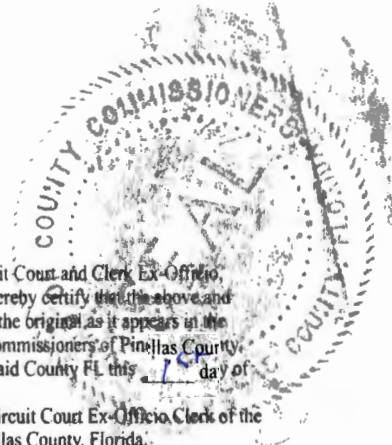

SECTION 9, TOWNSHIP 30 SOUTH, RANGE 15 EAST DESCRIPTION

A portion of Lot 6, Pinellas Groves, in the Northwest 1/4 of Section 9, Township 30 South, Range 15 East, according to plat thereof, as recorded in Plat Book 1, Page 55 of the Public Records of Pinellas County, Florida, and a portion of the Northwest 1/4 of Section 9, Township 30 South, Range 15 East, being more particularly described as follows:

Commence at the Northwest corner of Section 9, Township 30 South, Range 15 East, Pinellas County, Florida, thence S 89°01'34"E, along the North line of said Section 9, for a distance of 663.73 feet to a point of intersection with the Northerly extension of the West line of the lands described in Official Records Book 4688, Page 311, Public Records of Pinellas County, Florida and the Point of Beginning; thence S 00°09'10"W, along said Northerly extension, a distance of 40.00 feet to the Northwest corner of said lands; thence S 89°01'34"E, along the North line of said lands, a distance of 200.00 feet to the Northeast corner of said lands; thence N 00°09'10"E, along the Northerly extension of the East line of said lands, a distance of 40.00 feet to a point of intersection with the aforesaid North line of Section 9; thence N 89°01'34"W, along said North line of Section 9, a distance of 200.00 feet to the Point of Beginning.

Containing 8,000 square feet or 0.184 acre, more or less.

Basis of Bearings: Bearings shown hereon are based on the North line of Section 9, Township 30 South, Range 15 East, Pinellas County, Florida, being S89°01'34"E, as per Official Records Book 4688, Page 311, Public Records of Pinellas County, Florida.

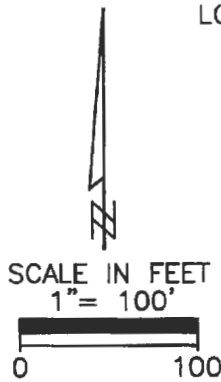
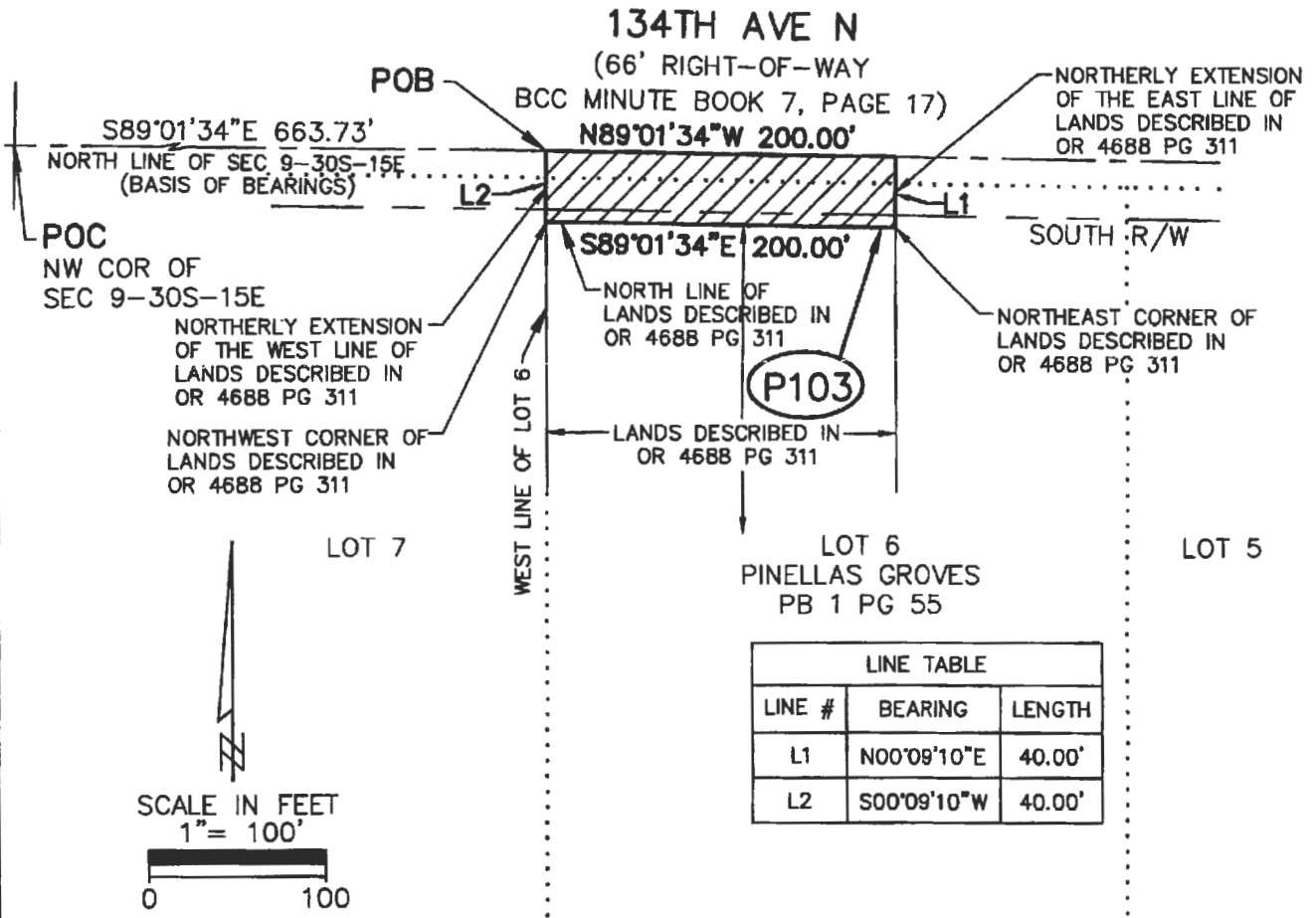
