FIRST AMENDMENT

This Amendment is made and entered into on the date last executed below ("Effective Date"), by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Polydyne Inc., hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on June 8, 2021, referred to as Pinellas County Contract No. 21-0091-B (hereinafter "Agreement"), pursuant to which the Contractor agreed to provide Polymers on an as needed basis for County; and

WHEREAS, Section 21 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a time extension and an increase to the total contract expenditure, at the same prices, terms, and conditions:

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- Section 5 ("Compensation and Method of Payment"), subsection B, is revised to reflect an increase in the amount of one million one hundred and fifty thousand dollars and zero cents (\$1,150,000.00) to the current not to exceed sum, for a revised total not to exceed amount of \$3,792,243. 24. In no event will the annual expenditure exceed \$622,707.40 in any given fiscal year without a written amendment to the Agreement.
- 2. In accordance with Section 4 ("Term of Agreement"), the term of the Agreement is extended an additional twenty-four (24) months from June 7, 2026, to June 7, 2028.
- Except as changed or modified herein, all provisions and conditions of the original
 Agreement and any amendments thereto shall remain in full force and effect
