

FIRST AMENDMENT

This Amendment is made and entered into this 16 day of January, 2024 by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Great Southern Equipment LLC, Tampa, FL hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on March 28, 2023, pursuant to Pinellas County Contract No. 23-00030-PB (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Vehicle and Equipment Replacement for County; and

WHEREAS, Section 37 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the total expenditure, weld brackets for the telestick, and the installation of a new broom rack, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

1. Section six (6) ("Term of the Agreement and Spending Cap"), is revised to reflect an increase in the amount of \$7,352.38, for a new total not-to-exceed amount of \$531,491.54.
2. Exhibit A ("Goods Pricing Schedule") is hereby deleted in its entirety and replaced with Revised Exhibit A attached hereto. The revised Exhibit A includes the welding of brackets for the Telestick and installation of a new broom rack.
3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.


