Deviating from the agenda, Attorney White indicated that the County Attorney’s Office (CAO) received a conflict waiver request from Carlton Fields, P.A. in order for one of their attorneys to represent The Dali Museum in its conversations with the County regarding funding; that the CAO is recommending approval of the conflict waiver; and that the waiver will allow a different Carlton Fields, P.A. attorney to speak with staff regarding the funding agreement.

Solid Waste

2. Annual certification of the Lealman Solid Waste Collection and Disposal District Non-Ad Valorem Assessment Roll with no rate increase.

Certificate approved, authorizing the Tax Collector to collect a non-ad valorem assessment from Lealman Community residential property owners for Solid Waste collection. Chairman authorized to certify the roll to the Tax Collector prior to September 15, 2025.

In response to a query by Commissioner Eggers, Mr. Burton indicated that the assessment fee previously approved by the Board for this year’s budget cannot be applied due to notice issues.

PUBLIC HEARINGS

All public hearing items have been properly advertised. Affidavits of Publication have been received and are on file in the Board Records Department.

BOARD OF COUNTY COMMISSIONERS

3. Resolution for the Surface Water Assessment within the unincorporated areas of Pinellas County.

Resolution No. 25-118 adopted, overriding previous rate Resolution No. 17-63 and proposing a 7% rate increase in Fiscal Year 2026 (FY26) and up to 5% annually thereafter, not to exceed \$179.11. Annual Surface Water Service Assessment rate will be \$133.65 per Equivalent Residential Unit in FY26. Eleven emails in opposition and one email of concern have been received by the Clerk.

Upon the Chair’s call for public comment, Dean Jarvis appeared and expressed his concerns; whereupon, Chair Scott indicated that staff will follow up with him.

Mr. Burton indicated that the Surface Water Assessment must be certified by September 15; whereupon, in response to queries by Chair Scott and Commissioner Eggers, he provided clarifying information regarding the impact of unfunded mandates and the proposed rate increase.

A motion was made by Commissioner Flowers, seconded by Commissioner Peters, that the item be approved. The motion carried by the following vote:
