**With a Formal Ceremony beginning at 3:00PM**



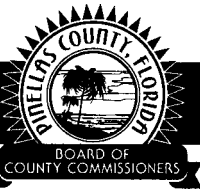
