## **NOTICE OF PUBLIC HEARING PROPOSED ORDINANCE AMENDING THE PINELLAS COUNTY CODE**

The Pinellas County Board of County Commissioners proposes to amend the Pinellas County Code by Ordinance.

A public hearing on the Ordinance will be held on Tuesday January 28, 2025, at 6:00 P.M. in the Pinellas County Communications – Palm Room, 333 Chestnut Street, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Ordinance.

### **1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:**

#### ORDINANCE NO. 24

AN ORDINANCE OF THE COUNTY OF PINELLAS RELATING TO THE COUNTY WATER AND NAVIGATION REGULATIONS (COUNTY CODE CHAPTER 58, ARTICLE XV); PROVIDING FOR A SPECIAL MAGISTRATE TO HEAR APPEALS AND VARIANCES; PROVIDING FOR THE PUBLIC WORKS DEPARTMENT INSTEAD OF THE CLERK OF COURT TO ACCEPT PERMIT APPLICATIONS AND ACCEPT FEES FOR SAME; ALLOWING COUNTY DREDGE AND FILL (INCLUDING SEAWALLS) PERMITTING REQUIREMENTS TO BE EXPEDITED AND FEES WAIVED ON A CASE-BY-CASE BASIS IN LIGHT OF A NATURAL DISASTER; EXTENDING CONTRACTOR LICENSING REQUIREMENTS ALREADY IN PLACE FOR DOCK CONTRACTORS TO DREDGE AND FILL AND SEAWALL CONTRACTORS; PROVIDING FOR COUNTYWIDE APPLICABILITY; PROVIDING FOR SEVERABILITY; PROVIDING FOR CODIFICATION; AND PROVIDING FOR AN EFFECTIVE DATE.

In review of the Ordinance above, there may be modifications that arise at the public hearing and/or with other responsible parties.

The proposed amendment to the Pinellas County Code can be inspected by the public at the Pinellas County Board Records Department, 315 Court Street, Fifth Floor, Clearwater, Florida 33756. Comments may be sent to this same address or call (727) 464-3458.

Persons are advised that if they decide to appeal any decision made at the meeting/hearing, they will need a record of the proceedings, and, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
