

**AMBULANCE SERVICE AGREEMENT  
AMENDMENT NO. 1**

**AGREEMENT** made this 22 day of December, 2025, between **PARAMEDICS LOGISTICS FLORIDA, LLC**, a foreign limited liability company registered to do business in Florida and with its principal place of business at 12490 Ulmerton Road, Largo, FL 33774 ("Contractor"), **PARAMEDICS LOGISTICS OPERATING COMPANY, LLC**, a foreign limited liability company with its principal place of business at 12200 US Highway 19 North, Hudson, FL 34667 ("Parent"), and **the PINELLAS COUNTY EMERGENCY MEDICAL SERVICES AUTHORITY**, a dependent special district established by Chapter 80-585, Laws of Florida, as amended ("Authority"). The Contractor, the Parent, and the Authority shall be referred to collectively as the "Parties."

WITNESSETH:

**WHEREAS**, the Authority and the Contractor entered into an agreement on September 5, 2024 (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Ambulance Services for the County; and

**WHEREAS**, Section 1001.1 of the Agreement states that any change in majority ownership of the Contractor shall, for purposes of the Agreement, be considered a form of assignment. The Authority shall not unreasonably withhold its approval of requested change in ownership, so long as the transferee can conclusively demonstrate the ability to perform all terms, conditions, meet financial and other obligations of the Ambulance Service Agreement.

**WHEREAS**, the Parent and Contractor will be acquired by affiliates of Grant Avenue Capital, LLC and Brave GAC Holdings, LP from the current owners A&M Capital Partners, LP and AMCP Paramedics Corp Holdings, LP.

**WHEREAS**, the Authority has determined that Brave GAC Holdings, LP has demonstrated its ability to perform any applicable terms and conditions, and meet any applicable financial and other obligations of the Agreement.

**WHEREAS**, Authority and the Contractor now wish to enter this Amendment in order to provide for the approval of the change in ownership.

**NOW THEREFORE**, the Parties agree that the Agreement is amended as follows:

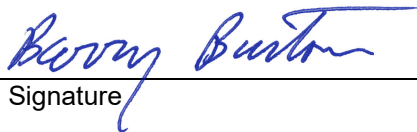
1. The Authority approves the change in ownership as requested pursuant to the terms of the Ambulance Service Agreement.
2. Except as changed or modified herein, all provisions and conditions of the Ambulance Service Agreement thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.

**IN WITNESS WHEREOF** the Parties herein have caused this Amendment No. 1 to be executed by their undersigned officials, who are duly authorized to bind the Parties to the Agreement.
