| City of Tarpon Springs Police<br>Department | Law Enforcement Programs                | \$               | Funding to purchase a Thermo Fisher TruNarc Handheld Analyzer with a one year warranty, including factory repair, loaner units when available, and 24/7 technical support. The TruNarc Analyzier enables officers to scan more than 530 suspected controlled substances in a single, definitive test. This will assist officers when encountering possible drug abusers and overdose situations. In the past year, officers have responded to 56 overdoses with 10 of those resulting in death. The NARK kits the officers currently use have become substantially expensive due to having to purchase multiple kits for each type of narcotic. The kits also have a shelf life and will expire if not used. The TruNarc Handheld Narcotics Analyzer can quickly identify drugs and keep officers safe from an accidental overdose. This system also will assist in prosecuting cases with an additional source of verification.   |
