Amendment No. 5 Service Agreement for Sludge Dryer Project

This Amendment No. 5 to the Agreement made and entered into this <u>1st</u> day of <u>August</u>, 2023, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "COUNTY", represented by its Board of County Commissioners (BCC), and Synagro-WWT, Inc., a corporation licensed to practice in Florida, hereinafter referred to as "CONTRACTOR".

WITNESSETH:

WHEREAS, the COUNTY entered into a Service Agreement for the Sludge Dryer Project, with the CONTRACTOR, dated April 5, 2001, ("AGREEMENT"), authorizing the operation of a sludge drying and pelletizing facility; and

WHEREAS, the Parties have previously executed four (4) amendments to the Agreement providing for adjustments as required to circumstances over the life of the Agreement to date; and

WHEREAS, the Agreement allows for the process and cost allocation associated with capital projects during the life of the Agreement, including those that become necessary due to regulatory changes; and

WHEREAS, the Parties accordingly wish to proceed with a capital project to be funded by the County as provided herein; and

WHEREAS, Pinellas County Utilities Department had previously contracted with Synagro to perform a "Dust Hazard Analysis" (DHA) identifying the need to perform this capital project; and

WHEREAS, the capital project will meet the process equipment requirements of the National Fire Protection Association's (NFPA) 652-2016.

NOW THEREFORE, the COUNTY and the CONTRACTOR, IN CONSIDERATION OF THE MUTUAL COVENANTS HEREINAFTER SET FORTH, AGREE AS FOLLOWS:

- 1. All provisions of the AGREEMENT and previous amendments shall remain in full force and effect except as modified herein.
- Payment of the fee to the CONTRACTOR for work authorized under this Amendment to the AGREEMENT shall be subject to the provisions of Article 6 of the AGREEMENT. Fees for additional services to be provided under this Amendment to the AGREEMENT shall be invoiced separately.

- 3. The CONTRACTOR shall provide the additional services as detailed in the attached document titled "2020 DHA UPGRADE PROJECT FOR DDS40" prepared by Andritz Separation, inc. dated 01-22-2021.
- 4. The COUNTY agrees to pay the CONTRACTOR a sum not-to-exceed \$1,390,359.20 for the additional services provided for in this Amendment, which includes the costs associated with CONTRACTOR's off-site disposal of up to 2,560 tons of Sludge produced by the COUNTY during the period when the capital project is being performed and the Facility is off line.
- 5. The total amount of Amendment No. 5 is an amount not-to-exceed \$1,390,359.20. Should the Sludge managed off-site exceed 2,560 tons, the COUNTY acknowledges that an additional amendment will need to be negotiated and agreed upon by the Parties to determine a mutually acceptable solution.

This Amendment No. 5 is effective the day and year first written above.
