Commissioner Eggers,

Please accept this correspondence as input from me as an individual, citizen, parent and business owner. I understand that there will be a vote on May 11 to end the county mask mandate. I am asking that you vote to end such a government mandate and allow individuals and individual business owners in public spaces to decide how they wish to proceed. This is supportive of individual responsibility, individual liberty and a strong step toward bringing us back to a state of normalcy.

What has troubled me throughout the pendency of this national emergency is the hysteria on both sides of the political aisle. Those of us who are parents and business owners are obviously forced to make decisions that effect the lives of others—sometimes in very unpopular ways. Those in political positions—such as yourself—are in a similar circumstance. Regardless of your decision, it will be unpopular with 50% of the electorate. So, what is the right course? My belief? The decision that supports individual decision-making and responsible choices.

I am a Goldwater/Reagan conservative—and a man of strong science background. I believe in individual responsibility, family responsibility followed by community responsibility—in that order. I am a strong believer in the efficacy of masks—if the right type and worn properly. My choices were always for my individual health. As callous as that sounds, I never wore a mask to protect others. If the right type and worn properly, I would keep my health and the health of my family intact. The SECONDARY benefit was to the community at large. Early on in this pandemic, I secured enough 3M 1860 and 8210 N95 masks for my entire family to last the entirety of this pandemic. I also secured enough KN95 masks for all my personnel at my office. It was the right course when science was uncertain and new courses were being charted about how to handle. I never needed a government to make these decisions for me. Ultimately, no masks were necessary for my personnel b/c I pushed them remote in February 2020—before any lockdowns. I took that position of leadership based upon what was known at that time. Candidly, I should not have to continue to wear masks for those who, at this point, are CHOOSING to be exposed. If people choose not to get vaccinated, that is their choice. I have now done everything I can do to protect myself, my family and the community—as has anyone else who has been vaccinated.

More importantly, it is time to allow the individual citizenry to make responsible choices for themselves. Nothing stops a person from protecting themselves when in public. And, the individual business owners can make responsible choices about how to conduct their business without the mandate of government.

I appreciate your attention to these issues and thank you for the indulging of my lengthy message.
