We appreciate the opportunity to provide our input and request that you enter our comments into the public record.

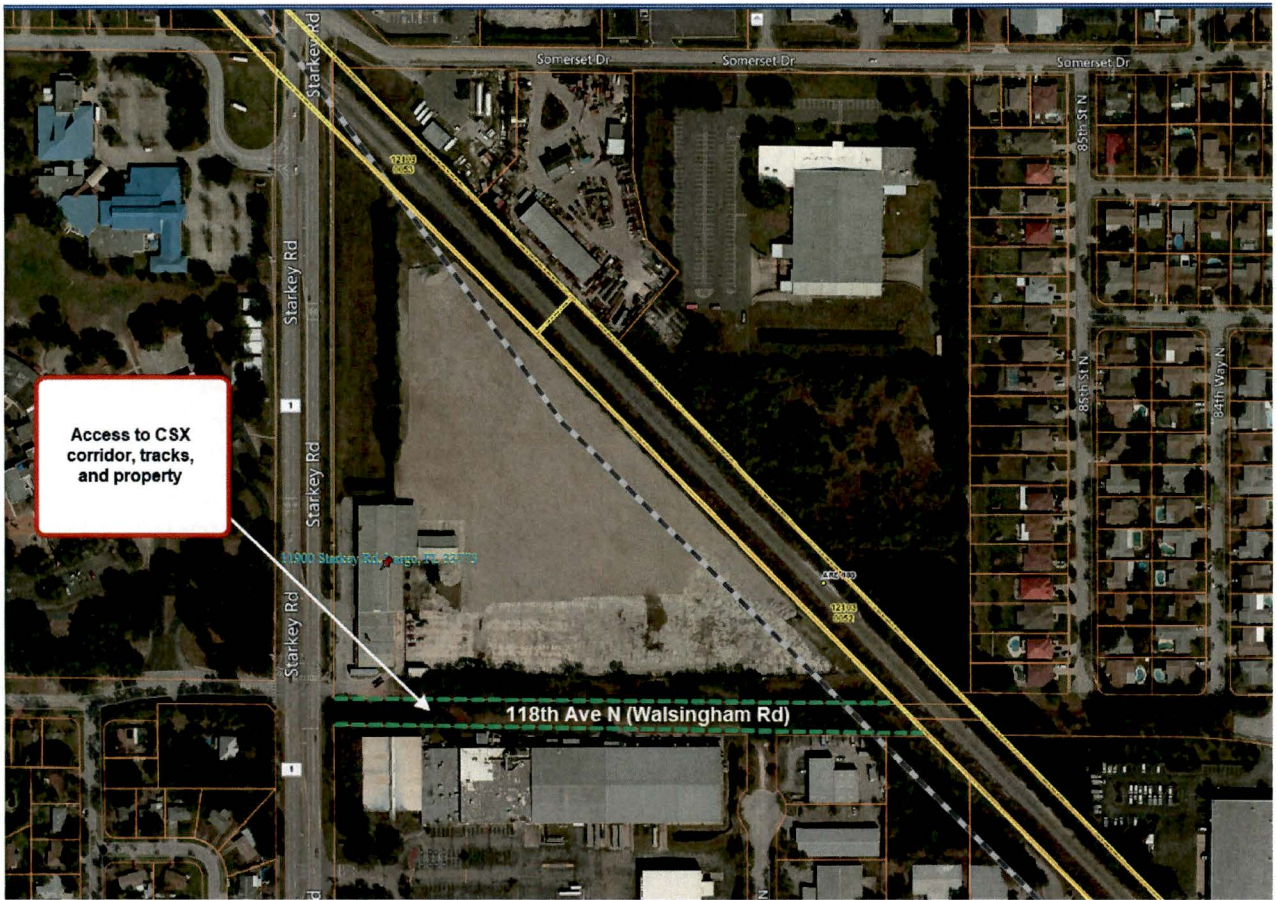
