### Description & Comments

(What is it, any issues found, is there a financial impact to current/next FY, does this contract vary from previous FY, etc.)

The St. Pete-Clearwater International Airport (PIE) is seeking the approval of the Public Transportation Grant Agreement (PTGA) with the Florida Department of Transportation (FDOT) for design and construction associated with the new parking garage at PIE. The grant is for a total of \$3,750,337.00 from FDOT and includes a County match of \$3,750,337.00 and has an expiration of June 30, 2029. Funding in excess of the match amount is available for other project costs.

This request is budgeted for in the FY26 Budget of PIE in the Airport Revenue and Operating Fund. It is specifically under Multi-Level Airport Parking Garage Project 002877A, included in the FY26-FY30 Capital Improvement Plan, and is funded by Airport Funds (AF), future grants (FTG), Customer Facility Charges (CFC), and State grants (SG) for a total amount of \$46,250,000 (Table 1). The Project has \$3,500,000 specifically budgeted in FY26.

While the current approved allocation through FY30 is \$46,250,000, more recent projections indicate a total cost estimate of \$61,500,000 due to lower than anticipated estimates during preliminary planning. In the event that future fiscal year funding is not available for this project, the County maintains the authority to terminate this agreement.
