Dear Mr. Hernandez:

Pinellas County requests Federal assistance under the provisions of section 216 of the Flood Control Act of 1950, Public Law 81-516 or section 403 of the Agricultural Credit Act of 1978, Public Law 95-334, to restore damages sustained in Pinellas County, Florida by Hurricane Milton on October 9, 2024. This work is needed to safeguard lives and property from an imminent hazard of flooding. Pinellas County is requesting funding for debris removal that is obstructing ditches, drainage channels, creeks, streams, and associated culverts and structures. Also, the County is requesting funding for streambank sloughing/erosion and structural wall failures, undermining, and washouts. These County maintained waterways serve primarily as drainage flood control systems and require assistance to eliminate immediate threats to life, public health, safety, and for the overall economic recovery of the community at large. Hurricane Milton's devastation deposited sedimentation, construction and demolition (C&D), and vegetative debris into the waterways, caused streambank sloughing/erosion, and structural failure damages to nearly 8.5 miles of County waterways, reference Attachment A listing the waterways and the length of damage. The County has developed maps that identify the damage at each waterway location, reference Attachment B. There is a great need to remove the debris and eliminate the immediate threat of flooding.

We are a County government with a responsibility for the values threatened by the watershed emergency. We understand, as sponsors of emergency watershed protection measures, that our responsibilities will include:

- Contributing a share of the project costs, as determined by Natural Resources Conservation Service (NRCS), by providing funds or eligible services necessary to undertake the activity.
- Obtaining any necessary real property rights, water rights, and regulatory permits.
- Agreeing to provide for any required operation and maintenance of the completed emergency measures.

The County has insufficient funding and resources available to provide adequate relief from the applicable hazards. The County is currently under an Emergency Final Order, OGC Number 24-2580, with the Florida Department of Environmental Protection (FDEP) that includes measures made necessary by Hurricane Milton. The County has requested guidance from the United States Army Corps of Engineers (USACE) regarding the required permits. The County acknowledges that NRCS may not provide funding for activities undertaken by a sponsor prior to the signing of an agreement between NRCS and the sponsor.
