Dear County Commissioners,

On Tuesday, you will be making a vote of historic significance to Pinellas County and St. Petersburg – the vote to approve or reject the sale of bonds to provide funds for a new baseball stadium.

We strongly urge you to vote NO - do not authorize Pinellas County to issue bonds to build a stadium. We don't think it is too strong to say that the future of our economy, our homes, our beaches, our infrastructure, and our jobs depend on it.

We know you agree we need to focus on what matters to make life better for all the citizens of Pinellas County. We are counting on you to not be blinded by a shiny object. – a pretty picture of a stadium – but to do what is right!!

Our recommendation is based on:

1. The significant impact of two hurricanes on our beaches and our homes and our economy and as a result where we need to refocus our resources.

2. The more likely risk of future damaging storms.

3. The uncertain sources of funds to repair the beaches and infrastructure now and to repair them when future storms are sure to come.

4. The risks to our tourism industry and the impact of that risk on more than 90,000 people's jobs – jobs that depend on tourism.

5. The undeniable facts that baseball does not drive economic growth and is not a significant source of tourism.

6. The Gas Plant site is ready for development and a stadium will not enhance that development. In some respects, the stadium will actually hurt development – traffic congestion, and a detraction from office and residential development. Thus, the property will generate the county's share of real estate taxes from its development more quickly without a stadium.

Why is it reported that Rays/Hines are still in interested in developing the property even without a stadium? They must also agree – contrary to what they said when they competed for the deal when they, the city and the chambers of commerce said that the stadium is an anchor for other development. The development of the rest of the property would be an anchor for a stadium.

7. The development of the land that would have been set aside for a stadium, could now be developed for commercial purposes, generating additional Pinellas County property taxes.

In July, when the Pinellas County Commission voted to authorize the use of Tourist Development Tax revenue to fund the Rays baseball stadium in St. Petersburg, it seems that those who voted in favor based their decision on:

1. Current Tourist Development Tax (TDT) reserves were sufficient for the current needs to re-nourish the beaches and future TDT funds would be sufficient in the event of any emergencies – like a hurricane, should one ever hit our coast.

2. Spending \$312.5 million of TDT (\$600 including interest) on a stadium was consistent with the goals for the use of TDT. There were no higher priorities.

But those assumptions are now seriously challenged. We have been hit by two hurricanes - the impact on the county is serious. And now we hope you would agree, we are all deeply concerned that we can get hit by future storms.

The beaches lost 30 years worth of beach re-nourishment from hurricanes Helene and Milton – and the cost of repairs are as much as \$130 million!!

To make the repairs, not only does it appear that the county will need to dig into the emergency funds and more, there is no guarantee that either the federal government or state goVermont will help pay the cost of repairs. Consider what about the potential \$130 million we will need after the next storm?

Can we afford to wait much longer? The longer we wait, the more the homes and infrastructure along the coast are exposed to further erosion and damage.

Can the county still afford to fund a baseball stadium based on where things stand?

Pinellas County has been "gut punched" by two storms in two weeks – something we never thought would happen. But now, with all of us concerned about when the next storm will hit our homes and businesses, trying to decide if we should rebuild or not, don't we have to fiscally plan about the next time? And consider the real possibility that it might happen more often?

No matter the reason, the waters of the Gulf of Mexico are warmer and warmer water breeds hurricanes. Never before now have we ever seen a hurricane form in the western part of the Gulf of Mexico and move directly east at us. But now that it has is happened, everyone should be aware it can happen again.

With these real concerns in mind, we need to have the funds for regular beach and infrastructure repairs. The beaches are the number one reason tourists come to Pinellas County, and tourism supports more than 90,000 jobs in the county, contributing over \$2.9 billion in wages. (The Visit St. Petersburg /Clearwater's report shows that, when queried, 40% of visitors come to our area for the beaches, the pier, the restaurants and the museums. Only 4% said they visit here for sporting events!!!).

Regarding the economic and real estate tax benefit of a stadium, more than 100 economic studies show that professional sports stadiums do not generate economic benefits. In the case of the Rays, they generate very limited tourism. Do not let ego having a MLB team trump our best interests.

Owners of baseball teams want to locate their teams in areas with fast growth in the hopes it will increase attendance – not the other way around.

We feel strongly that the need to focus on our infrastructure and our beaches takes precedence over this boondoggle.

In conclusion:

1. Two hurricanes have changed everything.

2. We don't need a stadium to see the economic, tourist and real estate tax benefits from the development of the Plant property.

**3**. As you know, approval of the deal with Rays/Hines to build a stadium and for them to develop the rest of the property was a two step process of approval by the county and the city.

In no way should you feel pressured by recent articles in the press. The time has come for courageous action.

We need to do what is right for the citizens of Pinellas County.

On Tuesday, you will be making a vote of historic significance to Pinellas County and St. Petersburg - the vote to approve or reject the sale of bonds to provide funds for a new baseball stadium.

I strongly urge you to vote No - do not authorize Pinellas County to issue bonds to build a stadium. I don't think it is too strong to say that the future of our economy, our homes, our beaches, our infrastructures, and our jobs depend on it. I know you agree we need to focus on what matters to make life better for all the citizens of Pinellas County. We are counting on you to not be blinded by a shiny object. - a pretty picture of a stadium. - but to do what is right.

My recommendation is based on:

1. The significant impact of two hurricanes on our beaches and our homes and our economy and as a result where we need to refocus our resources.

2. The more likely risk of future storms.

3. The uncertain sources of funds to repair the beaches now and to repair them when future storms are sure to come.

4. The risks to our tourism industry and the impact of that risk on more than 90,000 people's jobs - jobs that depend on tourism.

5. The undeniable facts that baseball does not drive economic growth and is not a significant source of tourism.

6. The Gas Plant site is ready for development and a stadium will not enhance that development. In some respects, the stadium will actually hurt development - traffic congestion, and a detraction from office and residential development. Thus, the property will generate the county's share of real estate taxes from its development more quickly without a stadium. (Why is it reported that Rays/Hines are still in interested in developing the property even without a stadium? They must also agree - contrary to what they said when they competed for the deal when they, the city and the chambers of commerce said that the stadium is an anchor for other development. The development of the rest of the property would be an anchor for a stadium.)

7. The development of the land that would have been set aside for a stadium, will now be developed for commercial purposes, generating additional Pinellas County property taxes.

In July, when the Pinellas County Commission voted to authorize the use of Tourist Development Tax revenue to fund the Rays baseball stadium in St. Petersburg, it seems that those who voted in favor based their decision on:

1. Current Tourist Development Tax (TDT) reserves were sufficient for the current needs to re-nourish the beaches and future TDT funds would be sufficient in the event of any emergencies - like a hurricane, should one ever hit our coast.

2. Spending \$312.5 million of TDT (\$600 including interest) on a stadium was consistent with the goals for the use of TDT. There were no higher priorities.

Fast forward to today, and those assumptions are being sorely tested. Who would have thought we could hit by not one but two hurricanes and the impact on our community. And now I hope you would agree, we are all worried that we can get hit by future storms.

Regarding the beaches, the beaches lost 30 years worth of beach re-nourishment from hurricanes Helene and Milton - and the cost of repairs - as much as \$130 million.

To make the repairs, not only does it appear that the county will aneed to dig into the emergency funds and more (no one could anticipate the damage TWO hurricanes would bring), there is no guarantee that either the federal government or the state will help pay the cost of repairs. And what about the \$130 million we will need after the next storm?

Immediately after the storms, there had been some hopeful signs from the Biden administration about funding. However, we've been in a holding pattern since November's election, and who knows if Trump will be as favorable to giving us support.

Can we afford to wait much longer? The longer we wait, the more the homes and infrastructure along the coast are exposed to further erosion.

### Can the county still afford to fund a baseball stadium based on where things stand?

Pinellas County has been gut punched by two storms in two weeks - something we never thought would happen. But now, with all of us worrying about when the next storm will hit our homes, trying to decide if we should rebuild or not, don't we have to worry about the next time our beaches will be torn about? And the impact on our homes? And the possibility that it might happen more often?

No matter the reason, the waters of the Gulf of Mexico are warmer and warmer water breeds hurricanes. Never before now have we ever seen a hurricane form in the western part of the Gulf and move directly east at us. But not that it has is happened everyone worries it can happen again.

With these real worries in mind, we need to have the funds for regular beach repairs. The beaches are the number one reason tourists come to Pinellas County, and tourism supports more than 90,000 jobs in the county, contributing over \$2.9 billion in wages. (The Visit St. Pete/Cleartwater's own report shows that, when queried, 40% of visitors come to our area for the beaches, the pier, the restaurants and the museums. Only 4% said they visit here for sporting events.)

Regarding the economic and real state tax benefit of a stadium, more than 100 economic studies show that professional sports stadiums do not generate economic benefits. In the case of the Rays, they generate very limited tourism.

Owners of baseball teams want to locate their teams in areas with fast growth in the hopes it will increase attendance - not the other way around.

I have attached here: <u>Last chance to avoid a major mistake</u>, what I wrote to each of you who were commissioners in July. I stand by everything I wrote then. And profoundly, what I wrote about the need to focus on our infrastructure and our beaches has now come true.

In conclusion:

1. Two hurricanes have changed everything.

2. We don't need a stadium to see the economic, tourist and real estate tax benefits from the development of the Gras Plant property.

3. Everyone knew then and they know now that the approval of the deal with Rays/Hines to build a stadium and for them to develop the rest of the property was a two step process of approval by the county and the city. That the deal was not a done deal until both steps happened. In no way should you feel pressured by recent articles in the press.

We need to do what is right for the citizens of Pinellas County.

The Stadium and Historic Gas Plant deal documents vouched for the sufficiency of St. Petersburg's utility systems. In April 2024 the City issued a Capital Improvement Plan (CIP) for the city's water, sewer, and stormwater systems. In late September and early October these systems failed us during Hurricanes Helene and Milton. We all now know that these systems were neither reliable nor resilient. A 2022 report by the Center for Ocean-Atmospheric Prediction Studies at Florida State University depicted an anticipated hurricane return period for the Tampa Bay area of 8-11 years. These facts strongly suggest that there are important questions that should be answered and issues considered by City Council before it votes to authorize issuance of \$287.5 million TIF bonds to fund a contribution in like amount to the Tampa Bay Rays.

- Will the \$5 billion allocated to the city's water, sewer and stormwater systems under the 2024 (CIP) improve these utility systems sufficiently to avoid future losses such as those our city's residents and businesses are trying to recover from today? Does the 2024 CIP itself need an upgrade to incorporate what was learned from the subsequent system failures?
- Is the \$5 billion allocation from the 2024 utility CIP just another in a series of well documented underestimates by city administration of the cost of providing these systems with sufficient capacity and resilience? Some of these prior estimates were \$326 million in 2017, \$1 billion in 2019, and \$3 billion in 2021.
- Will the 2024 CIP's 25-year implementation period for improvement of these utility systems provide too little too late in other words, with a likely return period of about 10 years, does this implementation period need to be shortened to 10 years to, hopefully, avoid another major utility system failure?

The city's 2025 operating budget is about \$910 million. The combined FY 2025 water, sewer, and stormwater CIP appropriation is about \$155 million. A \$5 billion 25-year CIP nominally requires, on average, \$200 million each year. A 10-year program nominally would require \$500 million each year – a sum which could not be practically carved out of a 910 million city annual operating budget. Do not approve the expenditure of hundreds of millions of public funds to retain an amenity the city can no longer afford. Adopt a resolution or policy that would require a new utilities CIP and a budget

review that identifies every source of funds that would enable the city to achieve a reliable and resilient utility system in the shortest possible time. If you divert significant funds to baseball, you stretch the implementation period for fixing these essential utility systems and increase the likelihood of hurricane loss.

In short, reduce risk to the extent you can as soon as you can. Because of financial constraints, the city likely cannot avoid at least one more significant loss attributable to the utility systems, but you may have mitigated the loss. That would be a win.

Dear Tampa Bay Times Editorial Board, I am writing to express my concerns regarding your recent editorial entitled "Pinellas Has Too Much at Stake to Scuttle Rays Stadium Deal" published on November 15th. You stated that it would be a "bad look" for the city or county to back out of the

stadium deal. However, it is crucial to remember that when the Rays entered into this		
contract, they did so knowing that it was contingent upon approval by the St.		
Petersburg City Council and the Pinellas County Board of Commissioners for the sale of		
bonds. This means the deal was always conditional, not final. Comparing this to a home		
sale, it is akin to a buyer's offer being contingent on obtaining financing – a common		
and understood part of such transactions. Should the buyer fail to secure a mortgage,		
the sale does not proceed. This is not a matter of trust; it is an inherent part of the		
process.		

You also mentioned that "kneecapping the agreement at this stage would send all the wrong signals to any business that might want to move" here. However, businesses and investors are well aware that deals subject to financing are not guaranteed until all conditions are met. To suggest otherwise is misleading and does not account for the complexities involved in large-scale financing projects.

Furthermore, our community recently endured two significant storms, which starkly highlighted our vulnerability and the urgent need for resilient infrastructure. The extensive damage to our water, sewage, and road systems requires immediate attention and substantial investment. Many residents have lost their homes and belongings. And virtually everyone is worried about the impact of the next storm. The long-term impacts on our community could be severe.

Given these circumstances, prioritizing essential infrastructure over a new stadium is not only reasonable but necessary. St. Petersburg has identified more than \$5 billion in capital improvements needed to the sewer and stormwater systems, and more than \$1 billion in seawall repairs. The idea that funding a stadium will bring significant community benefits lacks concrete evidence, especially compared to the clear and pressing need for hurricane preparedness and infrastructure improvements. Investing in these areas is essential for the safety and well-being of St. Pete's residents.

Additionally, your claim that "Pinellas can't be trusted" if the stadium deal falls through is unfounded. The process of finalizing such deals includes due diligence and ensuring that all conditions, including financing, are satisfactorily met. This is a fundamental aspect of responsible governance and financial management.

In conclusion, while the notion of a new stadium might seem appealing, the current situation demands a reevaluation of priorities. The safety, welfare, and resilience of our community must come first. I urge the Tampa Bay Times to consider the broader context and the critical needs of our residents when discussing this issue.
