Article 1 section 9 of the constitution, states that no "Bill of Attainder or Ex post Facto law" shall be passed.

Yet oddly Qualification requisite, in Article 1 section 2/a citizen, free to enumerate, and to place other people in bondage.

I also find <u>letters of Marque</u>, <u>reprisals</u> a war claimed as a "peacetime" capturing water in Article 1 section 8. I find Presentiment in the 5<sup>th</sup> Amendment, a bounty charge in section 4 of the 14<sup>th</sup> Amendment. I find "Freedom to press". The levy reveals that our government is (and has been) conducting <u>actual</u> wartime operations against the civilian population, aggregating, *deliberately* desecrating the sanctity of our water supply, using water as a faith based weapon. Intent on destroying Christianity in its variance. Pledging to the liberty for which <u>it</u> stands. Claiming "Mankind is more disposed to suffer while evils are sufferable". Claiming "In order to control mans will one must first control mans subsistence" in Fed #79.

Claiming freedom, as *an independent* power, free to levy war in the Declaration of Independence. Claiming Freedom to Depart from Almighty God under the Act of Thomas Jefferson.

The truth is this government has gone from a hold on reality, to actuality, to actually invade, as in actual time of war, as militia in the 5<sup>th</sup> Amendment. As militia called into actual service in Article 2 section 2, to invade in Article 1 section 9, to actually invade as will not admit any further delay in Article 1 section 10.

Resolution 95-286 III-f makes our essential water access a privilege. The underpinning of the water district levy is the beginning of actual wartime operations aggregated by factions within our government against its civilian population. George Washington forewarned that this act would "ultimately consume thee".
