**Summary:**

This is a civil action in which Plaintiff alleges negligence against the County and seeks monetary damages for personal injuries allegedly arising out of an auto accident on September 16, 2024, at or near the intersection of Highlands Blvd. N. and U.S. 19 N., Pinellas County, Florida. Plaintiff was riding a bicycle at the time of the accident.

Due to Plaintiff's medical bills, the nature of the accident and the potential liability exposure, it is recommended that the County Attorney's office be authorized to settle this claim in the amount of \$190,000.00, inclusive of all costs and claims for attorney's fees. Plaintiff has agreed to settlement pending BCC approval.

Approval of this settlement is recommended by Risk Management, County Administration, and the County Attorney's Office.
