Hurricane Idalia damage assessment and recovery efforts

Mr. Burton indicated that the Federal Emergency Management Agency (FEMA) and the State of Florida are helping the County with additional services for individual and rental assistance; that so far, 3,623 residents have applied for individual assistance; that disaster survivor teams are working to update applications in impacted areas; and that FEMA is verifying damages.

Mr. Burton related that staff will coordinate with state and federal inspectors to identify additional disaster recovery center locations; that the public assistance estimate is currently \$22.8 million; that small business and low interest disaster loans are available; and that FEMA is working with the state to schedule a joint preliminary damage assessment for public assistance; whereupon, he noted that staff is coordinating with the Florida Department of Children and Families in impacted zip codes where residents receive Supplemental Nutrition Assistance Program (SNAP) benefits; that staff has identified ten destroyed homes, 821 with major damage, 1,033 with minor damage, and an additional 828 that were affected; that some water-impacted homes also had sewage overflow; and that staff is trying to clarify how to reclassify those homes with regard to damage so that the residents receive the appropriate financial assistance.

Mr. Burton related that County staff is working with the Twin Cities and Mariner Cove mobile home parks which were heavily impacted, pointing out that Mariner Cove had the same issue over five years ago; and that a better long-term resolution is needed; whereupon, he discussed the assistance being provided by various entities.

In response to comments and queries by Commissioner Eggers, Mr. Burton indicated that an after-action report will be provided to the Board; whereupon discussion ensued regarding impacts from prior storms, as compared to Idalia.

Hurricane Idalia storm surge impacts on the beaches

Public Works Director Kelli Hammer Levy presented photographs of various locations and discussed the severe impacts of the storm on the coastline, noting the extensive beach erosion. In response to a query by Commissioner Latvala, she indicated that residents of beach communities are unwilling to sign an easement required by the United States Army Corps of Engineers (Corps) for beach renourishment based on issues of public access and use, perpetuality of the easements, and personal land rights.

Commissioner Peters discussed taking part in the flyover of the coastline with the Pinellas County Sheriff's Department and commented on the damage she saw; whereupon, Mr. Burton noted that he will share a video of the flyover which was provided by Pinellas County Sheriff Bob Gualtieri.

Mr. Burton related that Ms. Levy is currently working on emergency beach repairs and on a long-term solution, including whether the County can address the beach renourishment on its own, which would be costly, or modify the easement language to eliminate public access and use. He indicated that staff will be meeting with the consultant, who is a former Corps employee, to determine options; that there will be a meeting with the Corps tomorrow; and that staff will attend the Florida Association of Counties conference and attempt to unite the other ten counties that were impacted; whereupon, he noted that there are multiprong approaches to the issue; and that staff will bring back thoughts and ideas on strategy.

In response to comments and a query by Commissioner Eggers, Ms. Levy discussed the citizens' reservations regarding agreeing to an easement; whereupon, Commissioner Eggers indicated that the issue is one of public safety in an attempt to protect people's lives and property. Ms. Levy related that staff met with the Department of Environmental Protection (DEP) yesterday and the consultant this morning; that the Corps has some expedited processes for projects as a result of Hurricane Idalia; and that Senators Marco Rubio and Rick Scott have proposed a bill that, if passed, would waive easement requirements. She indicated that staff is looking at interim protective measures which have worked well post-Hurricane Ian, such as measures taken by Volusia County; and that it is important to get something in place while working on the bigger picture.

Commissioner Peters referenced correspondence provided by Ms. Levy, which indicates that the Corps policy cannot be so rigid as to affect the environment or the economy, and Mr. Burton provided brief comments.

In response to queries by Commissioners Scott and Flowers, Ms. Levy, with input by Mr. Burton, indicated that the easements which have already been signed would remain in effect if the County addresses the beach renourishment on its own, as the easements are issued to the County and not to the Corps; that public access and use designation does not give anyone the right to violate existing ordinances or state laws; and that a previous issue with regard to Pass-A-Grille Beach access was related to customary use law; whereupon, she provided information regarding the Project Cooperation Agreement with the Corps, including that the County is responsible for obtaining easements for construction, operation, and maintenance; and that the agreement does not mention public access and use. During discussion, Mr. Burton provided information regarding construction easements as opposed to perpetual easements, and noted that the County has the ability to legally take action for public safety.

Chair Long requested that Office of Management and Budget (OMB) Director Chris Rose research the level of financial reserves maintained by other counties which are surrounded by water as is the case with Pinellas County; whereupon, she questioned whether it was time to develop a policy to address the sand issue. In response to her query, Ms. Levy related that the cost of routine nourishment prior to Hurricane Idalia was estimated to be \$80 million, but that she does not have a new estimate, and discussion ensued.

In response to comments and queries by Commissioner Peters, Ms. Levy, with input by Mr. Burton, indicated that she will provide the members with a timeline for the emergency sand efforts at a later date and discussed the consultant's work to address the issue, temporary measures, and eligibility for FEMA assistance. She indicated that staff has requested for the Corps to provide the addresses for south county easements; that staff has met with the DEP regarding setting an erosion control line for the area, which is required before renourishment can occur; and that the County can still move forward with emergency measures in the meantime.

Thereupon, Mr. Burton related that damage assessments will be completed; that work will continue regarding emergency measures; and that he will be brief the Commissioners as updated information becomes available.

New County Complex Figures Update

Mr. Burton provided an explanation regarding a report previously presented to the Board related to a new County complex, noting that while the total cost listed in the report was correct, the updated version will include a more detailed breakdown of costs; whereupon, he provided additional information regarding the square footage and costs associated with parking.

BOARD OF COUNTY COMMISSIONERS

- 27.** Resolutions adopting tentative millage rates and budgets for Fiscal Year 2024 (first public hearing).

A public hearing was held regarding the proposed Fiscal Year 2024 tentative millage rates and budgets for Pinellas County; resolutions adopted approving the tentative millage rate (No. 23-72) and budget as amended (No. 23-73) for the Pinellas County General Fund; resolutions adopted approving the tentative millage rate (No. 23-74) and budget (No. 23-75) for the Pinellas County Health Department Fund; resolutions adopted approving tentative millage rates (No. 23-76) and budgets (No. 23-77) for the Emergency Medical Services Authority, Pinellas Planning Council, Unincorporated Area Municipal Service Taxing Unit (MSTU), Feather Sound Community Services District, and the unincorporated portions of the Belleair Bluffs, Clearwater, Dunedin, Gandy, High Point, Largo, Pinellas Park, Safety Harbor, Seminole, South Pasadena, Tarpon Springs, and Tierra Verde Fire Protection Districts; resolutions adopted approving the tentative millage rate (No. 23-78) and budget (No. 23-79) for the Public Library Services District MSTU; resolutions adopted approving the tentative millage rate (No. 23-80) and budget (No. 23-81) for the Palm Harbor Community Services District; resolutions adopted approving the tentative millage rate (No. 23-82) and budget (No. 23-83) for the East Lake Library Services District; and resolutions adopted approving the tentative millage rate (No. 23-84) and budget (No. 23-85) for the East Lake Recreation Services District.

Following opening remarks from Mr. Burton and upon the Chair's call for citizens wishing to speak, Christine Smith, Clearwater, appeared and provided input.

At the request of Chair Long, Ms. Revie reported that three letters in opposition have been received by the Clerk's Office; and that the Office of Management and Budget (OMB) has received 25 phone calls; whereupon, OMB Director Chris Rose clarified that the calls involved questions regarding the tentative budget.

Chair Long reviewed the sequence of events for the evening's proceedings, relating that Mr. Burton will provide an overview of the proposed budget, including changes that have been made following the BCC July 18 meeting; and that the final hearing will be held on September 19 to adopt the Fiscal Year 2024 final millage rates and budgets. At the request of Chair Long, Ms. Revie confirmed that there are no citizens pre-registered to speak virtually for today's hearing.

Chair Long indicated that a representative from the Property Appraiser's Office is available to assist anyone having questions or concerns regarding the assessed value, exemptions, or classifications related to their property, or information that appears on the Truth in Millage (TRIM) notice.

Chair Long related that even though Florida Statutes provide that a taxing authority may adopt tax levies and budgets of all its dependent special taxing districts and Municipal Service Taxing Units by a single unanimous vote, members of the general public can request that the Board discuss and adopt any of those items separately; whereupon, in response to her call for citizen participation, none requested that an item be separately reviewed.

Thereupon, Chair Long opened the first public hearing on the tentative millage rates and budgets for Fiscal Year 2024.

Ms. Revie reported that the public hearing is being held in accordance with Chapters 129 and 200 of the Florida Statutes; and that the meeting has been duly noticed by the Property Appraiser's mailing of the TRIM notice.

Chair Long announced that the BCC, as taxing authority for the BCC Countywide, the Dependent Special Districts, and the MSTUs, as listed above, will proceed with the public hearing.

Mr. Burton related that the percentage increase in the millage rate for all budgets over the rolled-back rate, based on the maximum rates on the TRIM notice and subsequent decreases to such rates, to fund the Fiscal Year 2024 tentative budget is a 8.46% increase over the aggregate rolled-back rate; whereupon, he indicated that the primary purpose for the increases in the millage over the rolled-back rate are as follows:

- In the General Fund, including Unincorporated Area MSTUs and the Emergency Medical Services Authority, revenue increases are required to support personnel and operating expenditures that are driven by inflationary factors and BCC priorities. The Pinellas Planning Council revenue increases are required for the same purposes, as per the request from Forward Pinellas.
- In the Public Library Services District MSTU, the Palm Harbor Community Services MSTU, the Feather Sound Community Services MSTU, the East Lake Library Services MSTU, the East Lake Recreation Services MSTU, and seven Special Fire Protection Districts, revenue increases are needed to support increased expenditures by the agencies providing services to those districts.
- In five Special Fire Protection Districts, the revenue need remained flat due to the districts having sufficient reserve levels to provide for future planned capital along with property values that can support annual operations.

Mr. Burton noted that a schedule of changes to the tentative budget was distributed to the BCC on September 5, 2023, and is attached to the agenda packet available online; that the modifications include changes discussed at BCC meetings or work sessions and technical adjustments related to accounting presentations, updated information, corrections, and other minor revisions.

Mr. Burton provided an overview of the tentative Fiscal Year 2024 annual operating and capital budget, discussing the basis for various budget recommendations and noting that the budget increase is largely a result of unfunded mandates by the State of Florida, contractual increases, and employee salary raises.

Chair Long announced that the BCC will continue the hearing as the taxing authority for the BCC Countywide, Dependent Special Districts, and MSTU levies by taking public comment from citizens wishing to be heard regarding the Fiscal Year 2024 Budget; whereupon, Ms. Revie confirmed that there are no additional citizens to be heard.

Discussion ensued regarding the following and other topics:

- Ensuring maximum efforts to assist taxpayers
- Spending within the County's means
- Reserve levels
- Reduced workforce
- Tourist Development Tax reevaluation
- Possible budget reductions
- Sustainability of the proposed budget
- Publishing the budget for each constitutional officer separately

During discussion, Mr. Burton, with input from Attorney White and Mr. Rose, responded to queries and comments by the members, and Christine Smith, Clearwater, provided additional remarks.

Noting that all public comment has been received, Chair Long queried the members as to any recommended changes to the tentative millage rates and budgets; whereupon, Commissioner Eggers proposed and moved that a 0.2 mill reduction be made to the General Fund tentative millage, and discussion ensued.

Mr. Burton related that the reduction to the millage would result in budget cuts across all departments and constitutional offices or cutbacks in road and sidewalk projects; whereupon, Commissioner Scott seconded the motion for discussion to continue, and Commissioners Latvala, Flowers, and Peters provided comments regarding the motion.

Upon call for the vote, the motion failed by a vote of 2 to 5, with Chair Long and Commissioners Peters, Flowers, Justice, and Latvala casting the dissenting votes.

Commissioner Latvala proposed that the Community Fund portion of the General Fund budget be cut in the amount of \$15,000.00.

A motion was made by Commissioner Latvala, seconded by Vice-Chair Peters, that the Community Fund portion of the General Fund budget be cut in the amount of \$15,000.00. The motion carried by the following vote:

Aye: 6 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Nay: 1 - Commissioner Flowers

Chair Long announced that resolutions will now be considered to set the tentative millage rates and budgets; and that resolutions for adopting the final millage rates and budgets are scheduled for the public hearing on September 19, 2023; whereupon, Mr. Burton announced each of the resolutions separately.

Mr. Burton recommended the adoption of the tentative millage rates for the General Fund and the Health Department Fund, as outlined on *Schedule A* which is included in the agenda packet; whereupon, Commissioner Flowers made a motion, which was seconded by Commissioner Peters. Upon call for the vote, the motion carried by a vote of 5 to 2, with Commissioners Eggers and Scott casting the dissenting votes.

Senior Assistant County Attorney Don Crowell suggested that the Board vote on each millage and budget for the General Fund, Health Department Fund, and the Dependent Special Districts and MSTUs separately.

Resolution No. 23-72 adopted approving the tentative millage rate for Fiscal Year 2024 for the Pinellas County General Fund.

A motion was made by Commissioner Flowers, seconded by Commissioner Justice, that the tentative millage rate for the General Fund be approved. The motion carried by the following vote:

Aye: 5 - Chair Long, Vice-Chair Peters, Commissioner Flowers, Commissioner Justice, and Commissioner Latvala

Nay: 2 - Commissioner Eggers, and Commissioner Scott

Resolution No. 23-73 adopted approving the tentative budget, as amended, for Fiscal Year 2024 for the Pinellas County General Fund.

A motion was made by Commissioner Flowers, seconded by Vice-Chair Peters, that the tentative budget for the General Fund be approved as amended. The motion carried by the following vote:

Aye: 5 - Chair Long, Vice-Chair Peters, Commissioner Flowers, Commissioner Justice, and Commissioner Latvala

Nay: 2 - Commissioner Eggers, and Commissioner Scott

Resolution No. 23-74 adopted approving the tentative millage rate for Fiscal Year 2024 for the Health Department.

A motion was made by Commissioner Flowers, seconded by Vice-Chair Peters, that the tentative millage rate for the Pinellas County Health Department be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-75 adopted approving the tentative budget for Fiscal Year 2024 for the Health Department.

A motion was made by Commissioner Flowers, seconded by Vice-Chair Peters, that the tentative budget for the Pinellas County Health Department be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Mr. Burton recommended the adoption of the tentative millage rate for the Emergency Medical Services Authority.

A motion was made by Commissioner Flowers, seconded by Commissioner Justice, that the tentative millage rate for the Emergency Medical Services Authority be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Attorney Crowell indicated that the Board can approve the Dependent Special Districts and MSTUs in a single unanimous vote, unless otherwise desired; whereupon, Commissioner Peters made a motion, which was seconded by Commissioner Flowers, to approve the tentative millage rates for the Dependent Special Districts and MSTUs, as depicted on *Schedule A*. Upon call for the vote, the motion failed with a vote of 6 to 1, with Commissioner Latvala casting the dissenting vote.

Mr. Burton related that a motion could be made to approve all Dependent Special Districts and MSTUs, excluding those for which Commissioner Latvala wishes to have independent votes.

Resolution No. 23-76 adopted approving the tentative millage rates for Fiscal Year 2024 for the Dependent Special Districts and MSTUs, excluding the Public Library Services District MSTU, Palm Harbor Community Services District, East Lake Library Services District, and East Lake Recreation Services District.

A motion was made by Commissioner Latvala, seconded by Commissioner Scott, that the Dependent Special Districts and MSTU tentative millage rates be approved (excluding Public Library Services District MSTU, Palm Harbor Community Services District, East Lake Library Services District, and East Lake Recreation Services District). The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-77 adopted approving the tentative budgets for Fiscal Year 2024 for the Dependent Special Districts and MSTUs, excluding the Public Library Services District MSTU, Palm Harbor Community Services District, East Lake Library Services District, and East Lake Recreation Services District.

A motion was made by Vice-Chair Peters, seconded by Commissioner Justice, that the Dependent Special Districts and MSTU tentative budgets be approved (excluding Public Library Services District MSTU, Palm Harbor Community Services District, East Lake Library Services District, and East Lake Recreation Services District). The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-78 adopted approving the tentative millage rate for Fiscal Year 2024 for the Public Library Services District MSTU.

A motion was made by Commissioner Eggers, seconded by Commissioner Flowers, that the tentative millage rate for the Public Library Services District MSTU be approved. The motion carried by the following vote:

Aye: 4 - Chair Long, Commissioner Eggers, Commissioner Flowers, and Commissioner Justice

Nay: 3 - Vice-Chair Peters, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-79 adopted approving the tentative budget for Fiscal Year 2024 for the Public Library Services District MSTU.

A motion was made by Commissioner Justice, seconded by Commissioner Flowers, that the tentative budget for the Public Library Services District MSTU be approved. The motion carried by the following vote:

Aye: 4 - Chair Long, Commissioner Eggers, Commissioner Flowers, and Commissioner Justice

Nay: 3 - Vice-Chair Peters, Commissioner Latvala, and Commissioner Scott

Commissioner Justice made a motion, which was seconded by Commissioner Flowers, that the tentative millage rate for the Palm Harbor Community Services District be approved. Upon call for the vote, the motion carried by a vote of 4 to 3, with Commissioners Peters, Latvala, and Scott casting the dissenting votes; whereupon, Attorney Crowell indicated that a five out of seven vote is required for the final adoption of the millage, but that the tentative millage would pass with a majority vote.

Attorney White related that a two-thirds majority vote is required to adopt the final millages and budgets; and that, at that time, the Board can choose to decrease the numbers approved today, but cannot increase them; whereupon, Commissioner Peters expressed interest in amending her vote, indicating that the proposed millage increase is small, and Commissioner Flowers stated that, per Robert's Rules of Order, the prevailing side can bring a motion back to the floor to be voted on again, and Chair Long brought the motion back to the floor.

A motion was made by Commissioner Flowers, seconded by Commissioner Justice, to reconsider the vote taken on the tentative millage rate for the Palm Harbor Community Services District. The motion carried by the following vote:

Aye: 6 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, and Commissioner Scott

Nay: 1 - Commissioner Latvala

Resolution No. 23-80 adopted approving the tentative millage rate for Fiscal Year 2024 for the Palm Harbor Community Services District.

A motion was made by Commissioner Flowers, seconded by Commissioner Eggers, that the tentative millage rate for the Palm Harbor Community Services District be approved. The motion carried by the following vote:

Aye: 5 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, and Commissioner Justice

Nay: 2 - Commissioner Latvala, and Commissioner Scott

Resolution No. 23-81 adopted approving the tentative budget for Fiscal Year 2024 for the Palm Harbor Community Services District.

A motion was made by Commissioner Justice, seconded by Vice-Chair Peters, that the tentative budget for the Palm Harbor Community Services District be approved. The motion carried by the following vote:

Aye: 6 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, and Commissioner Latvala

Nay: 1 - Commissioner Scott

Resolution No. 23-82 adopted approving the tentative millage rate for Fiscal Year 2024 for the East Lake Library Services District.

A motion was made by Commissioner Flowers, seconded by Commissioner Justice, that the tentative millage rate for the East Lake Library Services District be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-83 adopted approving the tentative budget for Fiscal Year 2024 for East Lake Library Services District.

A motion was made by Commissioner Flowers, seconded by Commissioner Justice, that the tentative budget for the East Lake Library Services District be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-84 adopted approving the tentative millage rate for Fiscal Year 2024 for the East Lake Recreation Services District.

A motion was made by Commissioner Flowers, seconded by Commissioner Eggers, that the tentative millage rate for the East Lake Recreation Services District be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Resolution No. 23-85 adopted approving the tentative budget for Fiscal Year 2024 for the East Lake Recreation Services District.

A motion was made by Vice-Chair Peters, seconded by Commissioner Scott, that the tentative budget for the East Lake Recreation Services District be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Attorney Crowell related that a vote regarding the tentative budget for the Emergency Medical Services Authority was not taken earlier in the meeting when the millage rate was approved; whereupon, Mr. Burton recommended adoption of the tentative budget for the Emergency Medical Services Authority.

A motion was made by Commissioner Eggers, seconded by Commissioner Scott, that the tentative budget for the Emergency Medical Services Authority be approved. The motion carried by the following vote:

Aye: 7 - Chair Long, Vice-Chair Peters, Commissioner Eggers, Commissioner Flowers, Commissioner Justice, Commissioner Latvala, and Commissioner Scott

Chair Long closed the first public hearing on the tentative millage rates and budgets for Fiscal Year 2024.

Mr. Burton stated that, in accordance with Florida Statutes, the County will advertise the Budget Summary and Notice of Tax Increase in advance of the second public hearing, which is to be held on September 19 at 6:00 P.M.; and that the notice will be published in the Tampa Bay Times on September 17.
