

NOTICE OF PUBLIC HEARING PROPOSED **ORDINANCE AMENDING THE PINELLAS COUNTY** **CODE**

The Pinellas County Board of County Commissioners proposes to amend the Pinellas County Code by Ordinance.

A public hearing on the Ordinance will be held on Tuesday, January 16, 2023, at 9:30 A.M. in 333 Chestnut Street, Palm Room, Clearwater, Florida 33756.

Interested parties may appear at the hearing and be heard regarding the proposed Ordinance amendment.

1. PROPOSED ORDINANCE TO AMEND THE PINELLAS COUNTY CODE:

AN ORDINANCE OF THE COUNTY OF PINELLAS, PROVIDING THAT THE PINELLAS COUNTY CODE BE AMENDED BY REVISING CHAPTER 86 OF SAID CODE; PROVIDING FOR REVISIONS TO SECTION 86-106 RELATED TO THE DEFINITIONS OF DRUG PARAPHERNALIA AND SPECIFICALLY EXCLUDE FENTANYL TESTING EQUIPMENT FROM THOSE DEFINITIONS; PROVIDING FOR SEVERABILITY; PROVIDING FOR AREAS EMBRACED; PROVIDING FOR INCLUSION IN THE CODE; AND PROVIDING FOR AN EFFECTIVE DATE.

In review of the Ordinance above, there may be modifications that arise at the public hearing and/or with other responsible parties.

Persons are advised that if they decide to appeal any decision made at the meeting/hearing, they will need a record of the proceedings, and, for such purposes, they may need to ensure that a verbatim record of the proceedings is made, which record includes the testimony and evidence upon which the appeal is to be based.
