C. Pricing & Expenditures Cap

D – Rate Sheets attached hereto. Notwithstanding the above, County expenditures under the
Agreement will not exceed \$450,000.00 for the contract term, with an annual expenditure of
\$150,000.00 per year, without a written amendment to this Agreement.

D. Entire Agreement
