**Description & Comments**

This item is for the award of bid to Kamminga & Roodvoets, Inc. for the 71st Street North, from 38th Avenue North to 54th Avenue North, Roadway, Drainage, and Sidewalk Improvements Project - American Rescue Plan Act.

- The Project includes road reconstruction, turn lane improvements, milling and resurfacing, stormwater improvements, sidewalk, curb, and mast arms to replace existing concrete strain poles at 38th Avenue N and 54th Avenue N.
- Three bids were received from Cone & Graham, Inc., David Nelson Construction Co., and Kamminga & Roodvoets, Inc. Kamminga & Roodvoets, Inc. is recommended for award as the lowest responsive and responsible bidder in the amount of \$15,375,809.15.
- All work is to be completed within 450 consecutive calendar days. Should the contractor fail to execute stated work within the designated timeframe, Kamminga & Roodvoets, Inc. will be responsible for reimbursing the County for any liquidated damages incurred.
- As satisfactory progress is made on this project, the County will issue partial payments to , Kamminga & Roodvoets, Inc. The County reserves the right, prior to issuing any payment, to request evidence of progress.
- The Small Business Enterprise goal is 13% for this contract.
- This construction agreement exceeds the Fiscal Year (FY)24-FY29 budget of \$10,911,000.00; However, the full construction agreement amount will not be spent in FY24, and Penny for Pinellas funding has been requested in the Proposed FY25-FY30 Capital Improvement Program plan to support the current project estimate. The contract contains a fiscal non-funding clause.

Funding is budgeted under the 71st Street N Roadway and Sidewalk Improvement from 38th Ave. N. to 54th Ave. N. Project 004539A, included in the Capital Improvement Plan, funded by the American Rescue Plan Act (ARPA) and the Penny for Pinellas.

The proposed Capital Improvement Plan fully reflects the project's anticipated cost at this time. In the event that future fiscal year funding is not available for this project, the County maintains the authority to terminate this agreement.
