

FIRST AMENDMENT

This Amendment made and entered into this 9th day of May, 2023, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Insight Public Sector, Inc hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on June 8, 2021 pursuant to Pinellas County Contract No. 21-0444-PB (hereinafter "Agreement") pursuant to which the Contractor agreed to provide IT Software Catalog Agreement for County; and

WHEREAS, Section 21. Amendment of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for an increase to the total contract expenditure and an extension, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

1. Section 5. Compensation and Method of Payment, subsection B is revised to reflect an increase to the Agreement in the amount of three hundred thousand dollars and zero cents (\$300,000.00), for a revised total not to exceed of one million, two hundred and fifty thousand dollars and zero cents (\$1,250,000.00).

2. Section 4. Term of Agreement, is revised to reflect a six (6) month extension, to reflect a new end date of October 31, 2023.

3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.
