A RESOLUTION OF THE BOARD OF COUNTY COMMISSIONERS OF PINELLAS COUNTY, FLORIDA; VACATING A PORTION OF A DRAINAGE, UTILITY AND/OR NATURAL AREA EASEMENT LYING IN LOT 8, BLOCK A, LAKE ST. GEORGE – UNIT 1, AS RECORDED IN PLAT BOOK 78, PAGES 65 thru 66, LYING IN SECTION 8-28-16, PINELLAS COUNTY, FLORIDA, PROVIDING FOR AN EFFECTIVE DATE.
