In accordance with the requirements of S. 218.36 (2), F.S., the Clerk has calculated the excess fees due to the Board totaling \$1,826,877.93. The Clerk's Annual Report and a copy of the check are attached.

While the Clerk's office has remitted excess fees on an annual basis for more than ten fiscal years, this year, we are requesting a portion of the excess fees be returned to the Clerk's office through an amendment. In FY23, the Board appropriated \$825,000 through a budget amendment. While these funds were estimated to be necessary in FY23 for a revenue shortfall, cost-saving measures were implemented to reduce our expenditures. The Clerk's office is requesting the same \$825,000 be re-appropriated for the purpose of subsidizing the expected FY24 medical insurance shortfalls in the Court and Recording funds.

In collaboration with the Office of Management and Budget, the budget amendment will be presented for your consideration at an upcoming BCC meeting.

The net of the excess fee remittance after the anticipated budget amendment remains substantial at \$1,001,877.93. Thank you for your continued support of the Clerk's office. Should you have any questions, feel free to contact me directly.
