MSTU Fund Proposal

I am proposing that we respond to the funds request from the Tierra Verde Community Association for the replacement of the children's playground surface and the installation of two sets of bleachers for seating at the baseball field at the Tierra Verde Recreational Complex. I have attached the documentation provided by the Association with regards to this request.

I propose that we expend from our \$220,000 MSTU grant fund as follows:

Playground Resurfacing

Up to \$5,000

**Bleacher Seating** 

Up to \$7,000

If we have consensus on these items, the Administrator will be directed to bring back appropriate budget authorizing language for approval at the soonest regular Commission Meeting.

**RE: REQUEST FOR GRANT FUNDS** 

Dear Commissioner Justice:

In early 2016 the Tierra Verde Recreational Complex started a rejuvenation process. This began as a complete maintenance program of our baseball field as well as the addition of a T-ball field for our 3-6 year olds. We installed new bases for Minor Leagues ages 6-10 and additional bases for Major Leagues ages 10-12. We installed clay throughout the entire ballfield and repaired a lawn mower and tractor for field maintenance. On February 2017 we signed an agreement with the Southwest Little League to manage their league at the Tierra Verde Recreational Complex. All improvements of the ballfield have been made with the immense help of Southwest Little League.

In addition, we have added one new batting cage, new turf, a new pitching machine and the addition of two pickle ball courts to the existing tennis courts.

We are requesting quotes for a new surface for the children's playground and bleacher seating. The playground originally had 12 inches of fiber mulch but currently only has 4 inches in most areas and is in desperate need of replacement.

TVCA would respectfully request for the Board of County Commissioners to vote to approve funding utilizing the grant money provided for Community Projects. These funds will thereby be used for the replacement of the children's playground surface as well as providing two sets of aluminum bleachers for seating at the baseball field.
