REASON FOR CHANGE:

This change order will add five new work order projects that are being approved noncompetitively per county code 2-180 as there is only one practicable and reasonable source for the purchase and utilizing a competitive process will be detrimental to timely securing the services to complete the work order projects by the end of 2024 under the current low-bid pricing. Other contractors have responded they are too busy to take on this work. Additionally, the work order projects are undertaken as repair or maintenance of an existing public facility and not as a new facility. This change order is initiated to complete the FY24 paving program.:

- 1. Project A-PID 004671A-Keene Road Resurfacing (Gulf to Bay Blvd Sunset Point Rd)
- 2. Project B-PID 005633A-Local Group 69 (Baywood Village Subd)
- 3. Project C-PID 005694A Local Group 71 (115th St N, 79th Ave 84th Ave, Ridgewood Cir)
- 4. Project D-PID 006195A-Dr M.L.K. Jr. Street N (Roosevelt Blvd J-275)
- 5. Project E-PID 005688A-38th Ave N Resurfacing (Tyrone Blvd 66th St)

The contractor agrees to conform to all existing contract specifications as well as those specific to this work.

There is no time extension associated with this change order.
