--Nonprofit Board (five years): Prior to moving to Florida in 2011, I served on the board of directors for a community revitalization nonprofit, LINC UP (formerly Lighthouse Communities) in Grand Rapids, MI. As board member, then secretary and later treasurer, I was very involved in the mission, goals, financial stewardship, hiring and appointing, community action, resource development, financial and other reporting, and other responsibilities. Most of all, I continually sought opportunities to identify needs and serve as an informed resource for the inner-city community where I lived and worked.

--Community Organizer and Program Facilitator (six years): Developed a citizenship training class and curriculum for refugees and immigrants pursuing US Citizenship. Grand Rapids resettled large numbers of refugees during my time there, and I partnered with a community clinic to provide language, citizenship testing, and community resource training to individuals across the city. Recruited volunteers, led training for nonprofits and churches for copying the program at

their facilities, and developed connections to needed legal, healthcare, and other resources for individuals and families resettling in the US.

--Ministry and Church (seven years): Served through church-planting and paraministries to meet needs of the homeless, prostitutes, addicts, others. Volunteered as group facilitator, chapel lead, volunteer organizer, and resource connector (for food, medical and dental care, housing, legal aid, domestic violence protection, immigration services, and other).
