Dear Ms. White,

First I wanted to thank you for incorporating the FL Statutory definition for " Bedroom." that I suggested into your Short Term Rental section of your land use ordinance.

That definition will help prevent investors from converting dinettes, hallways, offices and other habitable living spaces into areas they can cram in extra guests. It will likely save some lives in the event of fires. Hopefully future building projects in residential areas will now stay more residential in character too, and less dormitory-like.

Another item that will help keep the peace is a **prohibition on advertising of gatherings or commercial events at STRs**. I have seen some case law to support this prohibition. I believe Flagler County has this prohibition as well.

Indian Rocks has some useful language in this area you may wish to take a look at. The Indian Rocks ordinance was 2023-02 and the link to that municode section is here:

Sec. 18-214. – Advertising

(a) No Advertising Gatherings. **No vacation rental may be advertised as an event venue for gatherings such as weddings, corporate retreats, or film productions, which are likely or intended to draw attendance in excess of the permissible occupancy** as set forth in section 18- 216, or parking in excess of the restrictions set forth in section 18-218 of this Article.

Indian Rocks Beach is using Granicus to check online ads for compliance. I think it may be better to restrict the advertising in advance of these events rather than have code enforcement out on the weekends breaking up weddings!

I hope this info is helpful in crafting an improved ordinance to protect residents in unincorporated Pinellas and I will forward it to your commissioners for their review as well.
