

### Jackson County – Road Drainage Mitigation Project

- Through diligent and intentional advocacy efforts throughout the state budgeting process, Shumaker Advisors was able to procure **\$1.5 million** for Jackson County's unique road drainage mitigation projects in 2022. **City of Pensacola- Pensacola International Airport Passenger Terminal Building Expansion & Renewal**

- Funded at **\$5 million** in the FY 2024-2025 state budget, the Pensacola International Airport Terminal Expansion and Renewal project will revitalize the airport and ensure it can properly serve the more than three million passengers that travel through it annually. The City of Pensacola is initiating a **\$225 million** Airport Modernization and Expansion Program aimed at enhancing both capacity and passenger level of service. Central to the program is a **\$90 million** Passenger Terminal Expansion that will add five gates and more than double space for the Security Checkpoint. Funding obtained by Shumaker Advisors from the state will be instrumental in completing this major project.

An eighth-generation Floridian, Alan has built an advocacy career representing world- renowned research institutes, technology companies, small businesses, and clients in Tallahassee and Washington, D.C. 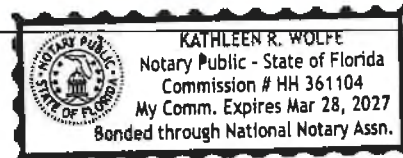

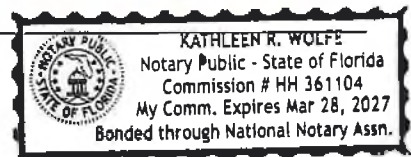
