

Houch,

Do you still have the page I gave you regarding the Pinellas County municipal code regarding the unlimited number of dog allowed in Pinellas County?

At the last meeting Renee expressed that we're a business not a residence but what home owner can care for an unlimited number of animals 24/7 where as we are FULLY STAFFED 24/7 so the dogs are NEVER ALONE. No home owner can even offer that kind of quality care. Besides the fact that our guest are only on the property for a LIMITED amount of time. In many cases only be for a few hours at best.

Also, it's been proven over and over again that people who own an unlimited number of animals cannot financially, physically or emotionally care for them all. Where as all of our dogs are properly medically treated for by their owners nor are emotionally deprived in any way.

In efforts financially endure the expenses from all of this and seek growth potential hopefully we can come to a compromise of no more than 75 dogs on the property at any given time. That's splitting the difference in our request and the staffs recommendation. We already have a supporting Animal Control Inspection Report that we can successfully care for 71 dogs which was even before we added the 800 square foot expansion.

Our staff report is not ready for distribution, but I want to inform you of our intent regarding the Precious Pets conditional use case. We do not intend to fully support the request as proposed. We believe it is too intensive for the site and surrounding area. However, we might support a fewer number of animals subject to conditions, something that would be more consistent with what has already been occurring on the site. Our staff report will reflect this position. Also, we intend to support the two variance requests, subject to conditions.
