1. Release final payment.

## **REASON FOR CHANGE:**

Final inspections have been conducted for all work performed under the contract terms by the representative of Public Works Department. Substantial completion for this project was achieved on January 24, 2017. The project was completed ahead of schedule with final acceptance granted on March 28, 2017. All work has been completed in accordance with the plans and specifications. The County has had beneficial use of all project areas since January 24, 2017. No liquidated damages shall be assessed.

Final pay quantities have been computed for the project and are adjusted to reflect the difference between the preliminary estimated quantities and the final quantities. This, and unused contingency funding resulted in a net total decrease of (\$222,537.50).

The Agreement term does not change as part of this change order.
