COUNTY ADMINISTRATOR DEPARTMENTS

Administrative Services

18. Lease with Sheltair Aviation for development and occupancy of a hangar and office space for Pinellas County Sheriff and waiver of the County's Indemnification Policy detailed in Resolution No. 06-70.

Lease agreement and waiver of Indemnification policy approved. No costs related to the agreement are expected in Fiscal Year 2024, and expenses for Fiscal Year 2025 and projected Fiscal Year 2026 (Year One) expenses are set forth in the Staff Report.

Referring to a PowerPoint presentation titled *Pinellas County Sheriff Hangar*, Administrative Services Director Joe Lauro provided information related to conditions of the current hangar, noting its advanced age, need for repairs, and insufficient size for effective use and details regarding the proposed solution for its replacement, including site, hangar specifications, timeline, and projected costs resulting from Sheltair constructing the hangar and subsequently leasing it to the County.

In response to queries by Commissioners Eggers and Scott, Administrative Services Deputy Director Diana Sweeney, with input by Messrs. Lauro and Burton, provided the following information:

- The total annual expense of \$2,267,382.00 includes ground rent, utilities, operating costs, real estate taxes, and insurance, and approximately \$617,000.00 of the total annual expense will be for operating costs outside of the triple net lease with Sheltair.
- Approximately one-third of the building will be utilized as office and training space.
- The proposed lease would be coterminous with the prime land lease currently held by Sheltair. The prime land lease ends in 2046, with two ten-year renewal options.
- The incremental increases over the course of the proposed lease are based on the Consumer Price Index, with a minimum of 3% and a maximum of 5% annually.
- Staff will provide a projected budget for the course of the 40-year proposed lease.
- There will be an approximate \$60,000.00 savings from ground rent for the current hangar site.
- Site constraints at the airport make the proposed lease the only viable alternative for moving the hangar project forward.

Responding to comments and a query by Chair Long, Sheltair Chief Operating Officer Todd Anderson indicated that the proposed lease is based on an estimated total project cost of \$20 million; that while the current design plans are conceptual and will require full permitting and architectural work to be completed, he believes that the estimate is sound; and that he hopes for the final total cost to be even less.

Sheltair Vice President, Design and Construction, Jack Tufano displayed conceptual images and a tentative timeline related to the project, as well as images of other Sheltair projects which he indicated have come in either on or below budget; whereupon, he related that it is anticipated that the Sheriff's hangar will take approximately 14 months to construct; and that the building will be designed and constructed to current Code and elevated above the floodplain.

In response to queries by Commissioners Scott and Latvala, Pinellas County's Sheriff's Office Assistant Chief Deputy David Danzig indicated that the facility will be staffed with current employees; that there would be cost savings from having the ability to utilize the Sheriff's Office Federal Aviation Administration maintenance and repair certification to perform repairs on-site; whereupon, he briefly explained the importance of site location, including the challenges with exploring a site located at the Tampa International Airport, related to the crucial nature of aircraft response times being within the required five minutes of an emergency situation.

Responding to a query by Commissioners Eggers, Mr. Anderson explained that Sheltair's typical rental rates are lower for a standard hangar and office space; and that the proposed project's rates are higher due to it being located on a five-acre parcel and complex completely dedicated to the Sheriff's Office; whereupon, also responding to a query by Commissioner Eggers, Mr. Lauro explained that the proposed project will be brought back to the Board for further consideration if the final total cost is more than the estimated total.

Economic Development

22. Three applications for funding under the Penny for Pinellas Employment Sites program.

Three applications for funding conditionally approved following completion of due diligence to comply with the program guidelines. Authority delegated to the County Administrator to negotiate and execute all agreements and associated documentation, as set forth in the Staff Report, for the following projects:

- Johnson Development Associates in the amount of \$2,151,867.00
- National Door and Hardware in the amount of \$327,000.00
- Racetrack 430 in the amount of \$1,100,000.00

Mr. Burton introduced the item and briefly summarized each application, noting that all three projects are what the Employment Sites Program was intended to support with regard to the County's overall redevelopment strategy.

Responding to queries by the members, Business Development Manager Teresa Brydon, with input by Mr. Burton, provided the following information:

- The Johnson Development Associates project, located in the Gateway Center Business Park, is a speculative building and does not yet have a tenant, but work is currently being done to fill the space. Funding through the Program will allow the developer to construct a building with larger square footage due, in part, to their ability to relocate an existing drainage field.

- Racetrack 430, located in Oldsmar, is a business with various products, but deals primarily with pharmaceuticals, and the project will assist with the relocation of one of their components from Pasco County into Pinellas County, including the addition of 25 positions.
- An overview of continual due diligence that takes place for projects selected, including working with a third-party vendor and assistance with creation of Program templates through the County Attorney's office, as well as utilization of a clawback system and all project documents being made a part of public record.
- If projects remain within the framework presented during this phase of conditional approval, the County Administrator is authorized to execute final agreements, and the projects will not be returned to the Board for additional approval. However, if any project falls outside of the framework, it will be returned to the Board for additional approval consideration.
- Established businesses can benefit from the Program by utilizing funding for expansions that could have been hindered due to financial constraints and which could then assist with retaining citizens in Pinellas County.

Commissioner Justice suggested that a yearly update be provided so that a discussion could occur regarding the policies which dictate how the Program is run; whereupon, Mr. Burton indicated that it could be done as part of a future work session.

Commissioner Flowers expressed appreciation for the Program's focus on employment opportunities and employee retention.

- 23.** Affordable Housing Program project funding recommendation for Burlington Post 2 by Green Mills Group.

Recommendation approved for funding in the total maximum expenditure amount of \$3,750,000.00 (\$3,541,977.00 from Emergency Rental Assistance 2 funds; \$208,023.00 of Housing Trust funds) for a new construction 75-unit multi-family senior development located in St. Petersburg. Total estimated development cost is \$28,406,761.00. County Administrator authorized to negotiate and approve the terms and final funding amounts not to exceed Board-approved amounts. Staff will complete additional due diligence activities, as set forth in the Staff Report.

Responding to a query by Commissioner Scott, Planning Division Manager Bruce Bussey indicated that the bond financing provides a 30-year affordability requirement for the development.

Commissioner Flowers expressed appreciation to the developer for providing an opportunity for senior citizens to have an affordable home.

A motion was made by Vice-Chair Peters, seconded by Commissioner Flowers, that the item be approved. The motion carried by the following vote:

24. Affordable Housing Program project funding recommendation for Heritage Oaks by Heritage Oaks, LLLP.

Recommendation approved for funding in the total maximum expenditure amount of \$3.36 million (\$1 million from Community Development Block Grant (CDBG); \$1.5 million from HOME Investment Partnerships Program; \$860,000.00 from State Housing Initiatives Program) for the first phase of redevelopment of Rainbow Village public housing complex, located in Largo and consisting of 80 newly-constructed multi-family senior units. Total estimated development cost is \$28,983,622.00. County Administrator authorized to negotiate and approve the terms and final funding amounts not to exceed Board-approved amounts. Staff will complete additional due diligence activities, as set forth in the Staff Report.

Commissioner Flowers remarked on how the project will serve households at or below 60% area median income.

In response to a query by Commissioner Scott, Planning Division Manager Bruce Bussey indicated that funding provided through the CDBG and HOME requires a minimum of a 20-year affordability period for the project.

Total estimated development cost is \$23,586,792.00. County Administrator is delegated authority to execute loan documents, restrictive covenants, and any other such agreements and documentation associated with funding in the amount authorized by the Board.
