WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on October 7, 2021, pursuant to Pinellas County Contract No. 189-0354-B (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Landscape and Irrigation Maintenance Services for County; and

WHEREAS, Section 22 ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for additional service locations and increase the total not-to-exceed amount, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- 1. Section six (6) ("Compensation and Method of Payment"), subsection B, is revised to reflect an increase in the amount of Three hundred and forty thousand, five hundred fifteen dollars and zero cents (\$340,515.00), for a new total not to exceed sum of One million, three hundred twenty-nine thousand seven hundred three dollars and zero cents (\$1,329,703.00).
- 2. Exhibit C ("Payment Schedule") is hereby deleted in its entirety and replaced with the revised Exhibit C ("Payment Schedule") attached to this amendment herein as Exhibit C.
- 3. Except as changed or modified herein, all provisions and conditions of the original Agreement and any amendments thereto shall remain in full force and effect.

Each Party to this Amendment represents and warrants that: (i) it has the full right and authority and has obtained all necessary approvals to enter into this Amendment; (ii) each person executing this Amendment on behalf of the Party is authorized to do so; (iii) this Amendment constitutes a valid and legally binding obligation of the Party, enforceable in accordance with its terms.
