## FIRST AMENDMENT

This Amendment made and entered into this <u>11</u> day of <u>May</u>, 2023, by and between Pinellas County, a political subdivision of the State of Florida, hereinafter referred to as "County," and Florida Dream Center, 4017 56<sup>th</sup> Ave. N., St. Petersburg, FL 33714 hereinafter referred to as "Contractor," (individually referred to as "Party", collectively "Parties").

## WITNESSETH:

WHEREAS, the County and the Contractor entered into an agreement on March 8, 2022, pursuant to Pinellas County Contract No. 21-0110-B (hereinafter "Agreement") pursuant to which the Contractor agreed to provide Lealman Community Redevelopment Area (CRA) Alley Maintenance Services for County; and

WHEREAS, Section Twenty-Two ("Amendment") of the Agreement permits modification by mutual written agreement of the parties; and

WHEREAS, the County and the Contractor now wish to modify the Agreement in order to provide for a renewal of contracted services, at the same prices, terms, and conditions;

NOW THEREFORE, the Parties agree that the Agreement is amended as follows:

- In accordance with Section 4 Term of Agreement, subsection B the Parties agree to exercise a Twelve (12) month extension for a new contract end date of March 7, 2024.
- 2. Section 5 Compensation and Method of Payment, subsection B is revised to reflect an increase in the amount of Sixty-Three Thousand, Eight Hundred Fifty-Five Dollars and Zero Cents (\$63,855.00), for a new total not-to exceed sum One Hundred Twenty-Seven Thousand, Seven Hundred Ten Dollars and Zero Cents (\$127,710.00). With an annual not-to-exceed expenditure of Sixty-Three Thousand, Eight Hundred Fifty-Five Dollars and Zero Cents (\$63,855.00).
- Except as changed or modified herein, all provisions and conditions of the original
   Agreement and any amendments thereto shall remain in full force and effect.
